Re: Application of Encana Oil & Gas (USA) Inc. for administrative approval of unorthodox well locations in the Counselor Gallup-Dakota Oil Pool (13379) for its Lybrook E27-2306 03H and Lybrook E27-2306 01H wells in Section 28, Township 23 North, Range 6 West, N.M.P.M., Sandoval County, New Mexico.

Dear Ms. Bailey:

Encana Oil & Gas (USA) Inc. (OGRID No. 282327) seeks administrative approval of an unorthodox well location for its Lybrook E27-2306 03H and Lybrook E27-2306 01H wells. Encana intends to drill the above mentioned horizontal laterals within two (2) miles of the Counselors Gallup-Dakota Oil Pool. The Counselors Gallup-Dakota Oil pool is a listed pool under Division Order R-12984, and is therefore governed by the Special Rules and Regulations adopted under Division Order R-7034. Rule 2 of these special rules require 160 acres spacing units and Rule 4 requires all wells to be located no closer than 660 feet to the outer boundary of the spacing unit and further requires that each well be no nearer than 1320 feet to the nearest well drilling to or capable of producing from the same pool. The NE/4 and the NW/4 of Section 28, T-23-North, R-6-West have been combined to form the project area for these proposed wells.

The penetration points for both the Lybrook E27-2306 03H well and the Lybrook E27-2306 01H well will be 330 feet from the East boundary of the N/2 of Section 28. These wells will also be closer in proximity than 1320 feet. The above mentioned wells are therefore unorthodox under these special rules.

Rule 5 of the Special Rules, as well as Rules 19.15.15.13(B) and 19.15.4.12(A)2 NMAC, allow the director to grant an exception to the well location requirements so long as no affected party, as defined in the Division Rules, objects to the application.

Enclosed as **Exhibits A1 and A2** are the C-102s for the Lybrook E27-2306 03H and the Lybrook E27-2306 01H reflecting the location of the proposed wells.



Enclosed as **Exhibit B** is a land plat showing the leases and all working interest owners in the spacing units to the Northeast, East and South of the N/2 of Section 28. Enclosed as **Exhibits C1 and C2** are JMJ Land's waiver of the 20 day notice period and acceptance of the proposed non-standard locations and Dugan Production Corporation's waiver. Since different federal leases are involved, the BLM has also been notified of this application.

Your attention to this matter is appreciated.


