Reference is made to your application received on December 5, 2013.

You have requested to drill this well at an unorthodox oil well location described above in the referenced pool or formation. This location is governed by statewide Rule 15.9.A [19.15.15.9.A NMAC], which provides for 40-acre units with wells located at least 330 feet from a unit outer boundary. This location is less than 330 feet from a unit outer boundary. Even though the surface location is unit K, the entire perforated interval is located in unit N of section 18. Refer to ProDirectional survey completion report that lists the perforated interval depth and location.

It is our understanding that you are seeking this location to recover additional oil and gas reserves.


