Pursuant to Division Rule 19.15.15.13, Mewbourne Oil Company ("Mewbourne") respectfully requests administrative approval of an unorthodox oil well location for its proposed Marathon Road 14 MD Federal Well No. 1H. This well will be drilled as a horizontal development oil well in the Lea-Bone Spring Pool (37570).

The Marathon Road 14 MD Federal Well No. 1H will be dedicated to a 160-acre spacing and proration unit ("project area") comprising the W/2 W/2 of Section 14. There are currently no other existing Bone Spring producing wells within the project area.

The Lea-Bone Spring Pool is currently governed by "The Special Rules and Regulations for the Lea-Bone Spring Pool" as established by Division Order No. R-1827 dated December 8, 1960. These rules require standard 80-acre spacing and proration units comprising the N/2, S/2, E/2 or W/2 of a governmental quarter section with wells to be located within 150 feet of the center of a governmental quarter-quarter section.

Pursuant to these rules, a well in the Lea-Bone Spring Pool cannot be located closer than 510 feet to a direct offset tract, and cannot be located closer than 783 feet to a diagonal offset tract.

The proposed unorthodox location is necessary in order to maximize the recovery of oil and gas reserves from the Lea-Bone Spring Pool underlying the W/2 W/2 of Section 14.

The affected offset tracts are described as follows:

Tract 1: W/2 W/2 of Section 23-20S-34E. This existing 160-acre Bone Spring horizontal project area is operated by Nearburg Producing Company. The well to which this tract is dedicated has not yet been drilled;

Tract 2: E/2 W/2 of Section 23-20S-34E. This existing 160-acre Bone Spring horizontal project area is operated by Nearburg Producing Company. The well to which this tract is dedicated is currently active;

Tract 3: W/2 W/2 of Section 11-20S-34E. This existing 160-acre Bone Spring horizontal project area is operated by COG Operating, LLC. The well to which this tract is dedicated is currently active;

Tract 4: E/2 W/2 of Section 11-20S-34E. This existing 160-acre Bone Spring horizontal project area is operated by COG Operating, LLC. The well to which this tract is dedicated has not yet been drilled;

Tract 5: S/2 SE/4 & NE/4 SE/4 of Section 10-20S-34E: This tract is currently undeveloped in the Bone Spring formation. The leasehold owner of this tract is Read & Stevens, Inc; and

Tract 6: E/2 E/2 of Section 15-20S-34E: This existing 160-acre Bone Spring horizontal project area is operated by Mewbourne Oil Company. The well to which this tract is dedicated is currently active. **(Please note that the working interest ownership between the drill tract (W/2 W/2 of Section 14) and this tract is not common. Consequently, Mewbourne is providing notice of this application to all WI owners in the E/2 E/2 of Section 15).**

Pursuant to Division rules, notice of this application is being provided to Read & Stevens, Inc., COG Operating, LLC, Nearburg Producing Company and to all working interest owners in the E/2 E/2 of Section 15 (See attached notice list).

Attached is a Form C-102 showing the proposed well and proposed project area. Also attached is a map showing the affected offset acreage, an offset leasehold notice letter and a notice list.

In summary, approval of the application will provide Mewbourne Oil Company the opportunity to recover additional oil and gas reserves from the Lea-Bone Spring Pool underlying the W/2 W/2 of Section 14 that may otherwise not be recovered, thereby preventing waste, and will not violate correlative rights.
