Pursuant to Division Rule 19.15.15.13, COG Production LLC (COG) respectfully requests administrative approval of an unorthodox oil well location for its Eata Fajita State #8H well. This well does not meet the 330' from the outer boundary of the producing area requirement. COG Production LLC has drilled and is currently producing Bone Spring wells in this section as described below.

Eata Fajita State #1H	SHL: 190' FSL & 660' FWL	BHL: 360' FNL & 660' FWL
Eata Fajita State #2H	SHL: 420' FSL & 2105' FWL	BHL: 372' FNL & 2056' FWL
Eata Fajita State #3H	SHL: 190' FSL & 2073' FEL	BHL: 348' FNL & 2073' FEL
Eata Fajita State #4H	SHL: 190' FSL & 380' FEL	BHL: 345' FNL & 421' FEL

We plan to test infill drilling in a lower target within the 2nd Bone Spring Sand to enhance hydrocarbon recovery between the existing wellbores.

The affected offset tract is the W/2W/2 of Section 8, T24S, R33E. COG Production LLC is the designated operator of all of Section 8, T24S, R33E.

Attached is a Form C-102 showing the project area and the producing area of this well.

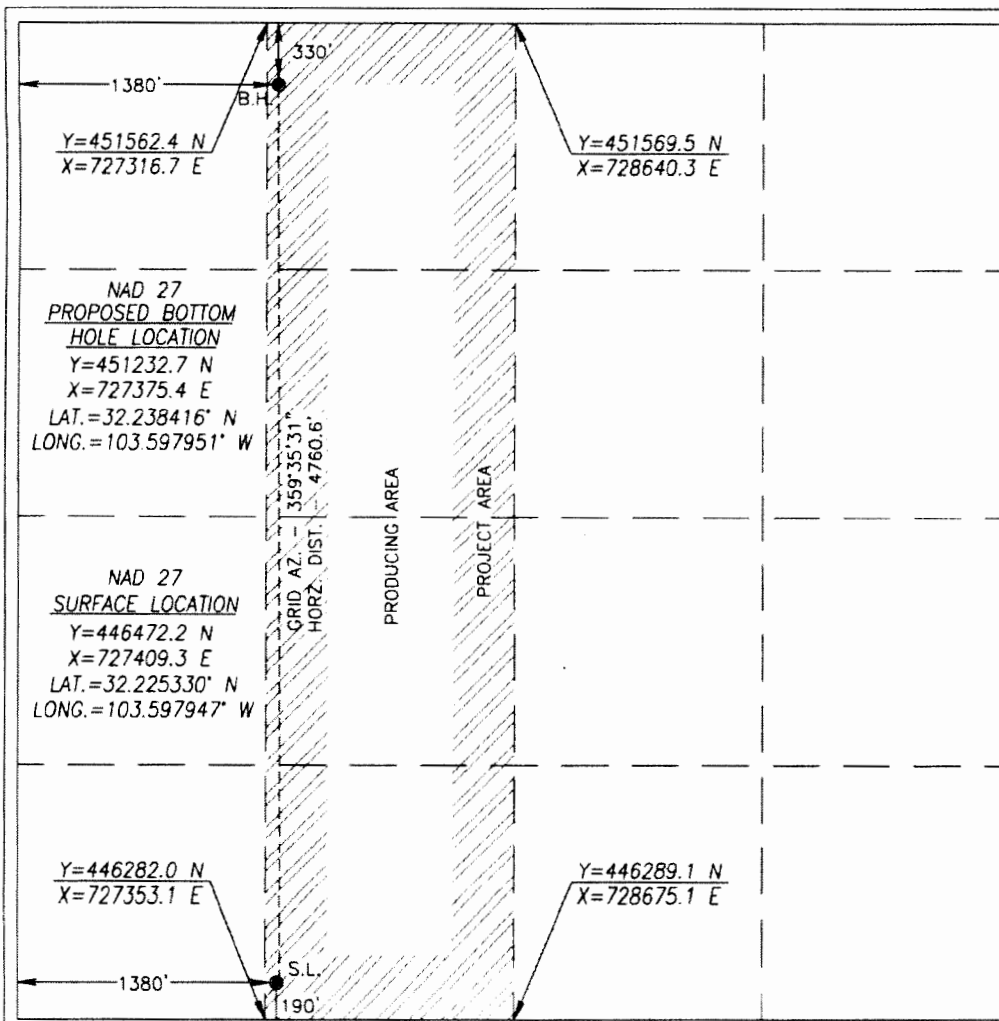
