The commingled oil and gas production from the wells detailed above shall be measured and sold at the Arabian 6 Fee Well No. 1 central tank battery (CTB), located in Unit M, of Section 6, Township 19 South, Range 26 East, NMPM, Eddy County, New Mexico.

The oil and gas production from each well shall be continuously measured for the Arabian 6 Fee Well No. 1 and the Arabian 6 Fee Well No. 10H with allocation meters before commingling with production from other wells. The Arabian 6 Fee Well No. 2H and Arabian 6 Fee Well No. 6H have common ownership; therefore these wells shall be metered together along with testing, before commingling. The allocation meters shall be calibrated semi-annually in accordance with Rule 19.15.12.10.C (2) NMAC.

This installation shall be installed and operated in accordance with the applicable Division Rules. It is the responsibility of the producer to notify the transporter of this commingling authority.


The operator shall notify the Artesia District office of the Division prior to implementation of the commingling operations.
