The project area for these wells include the E/2 of Section 8, Township 19 South, Range 26 East, NMPM, Eddy County, New Mexico.

The commingled oil and gas production from the wells detailed above shall be measured and sold at the Bradley 8 Fee Well No. 3H central tank battery (CTB), located in Unit O of Section 8, Township 19 South, Range 26 East, NMPM, Eddy County, New Mexico.

The oil and gas production for the Bradley 8 Fee Well No. 3H, Bradley 8 Fee Well No. 7H, and Bradley 8 Fee Well No. 27H wells, which have identical ownership, shall be measured with a combination of well testing and allocation meters before commingling with production from the other wells. The oil and gas production for the Bradley 8 Fee Well No. 4H and Bradley 8 Fee Well No. 8H wells, which have identical ownership, shall be measured with a combination of well testing and allocation meters before commingling with production from the other wells.


The allocation meters shall be calibrated quarterly in accordance with Rule 19.15.12.10.C (2) NMAC.

This installation shall be installed and operated in accordance with the applicable Division Rules. It is the responsibility of the producer to notify the transporter of this commingling authority.

This Division Order supersedes Division Order CTB-722, issued on July 9, 2014.

The operator shall notify the Artesia District office of the Division prior to implementation of the commingling operations.
