ConocoPhillips Company respectfully requests a non-standard location exception to produce the Golden Spur 36 COM W1 2H (APD pending approval). The surface hole location is on the E00920000 lease in Lot 1, 315' FNL & 570' FEL of Section 36, Township 26S, Range 31E, Eddy County, New Mexico. The bottom hole location is on lease serial number NMLC068282B in UL A, 50' FNL & 1040' FEL of Section 25, Township 26S, Range 31E, Eddy County, New Mexico. The lateral is 280' from the project area.

The first take point is estimated to be 330' FSL and 1040' FEL in Section 36, Township 26S, Range 31E and the wells last take point is estimated to be 330' FNL & 1040' FEL in Section 25, Township 26S, Range 31E.

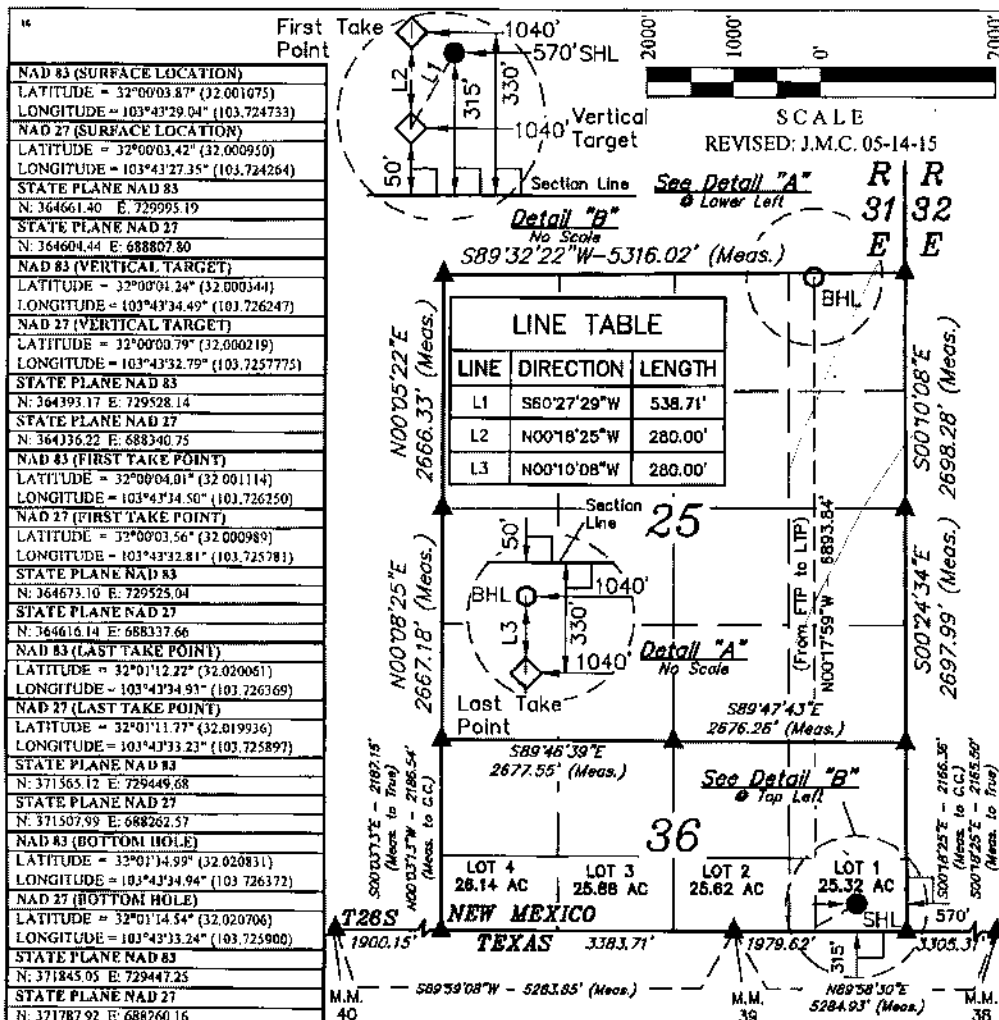

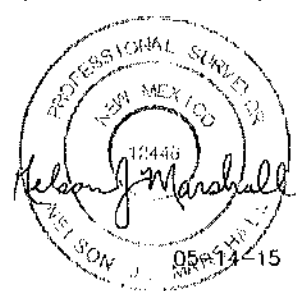
