Dear Mr. McMillan:

ConocoPhillips Company respectfully requests a non-standard location exception to produce the Stampede 34 Federal 5H(APD pending approval). The surface hole location is on the NMLC068282B in Lot 4, 250' FSL & 1040' FWL of Section 34, Township 26S, Range 31E, Eddy County, New Mexico. The bottom hole location is on lease serial number NMLC068282A in UL D, 50' FNL & 1040' FWL of Section 27, Township 26S, Range 31E, Eddy County, New Mexico. The lateral is 280' from the project area.

The first take point is estimated to be 330' FSL and 1040' FWL in Section 34, Township 26S, Range 31E and the wells last take point is estimated to be 330' FNL & 1040' FWL in Section 27, Township 26S, Range 31E.

The Bureau of Land Management encouraged this location to be used because of cave/karst considerations and to avoid nearby drainage ditches. The granting of this request is not expected to cause waste of resources.

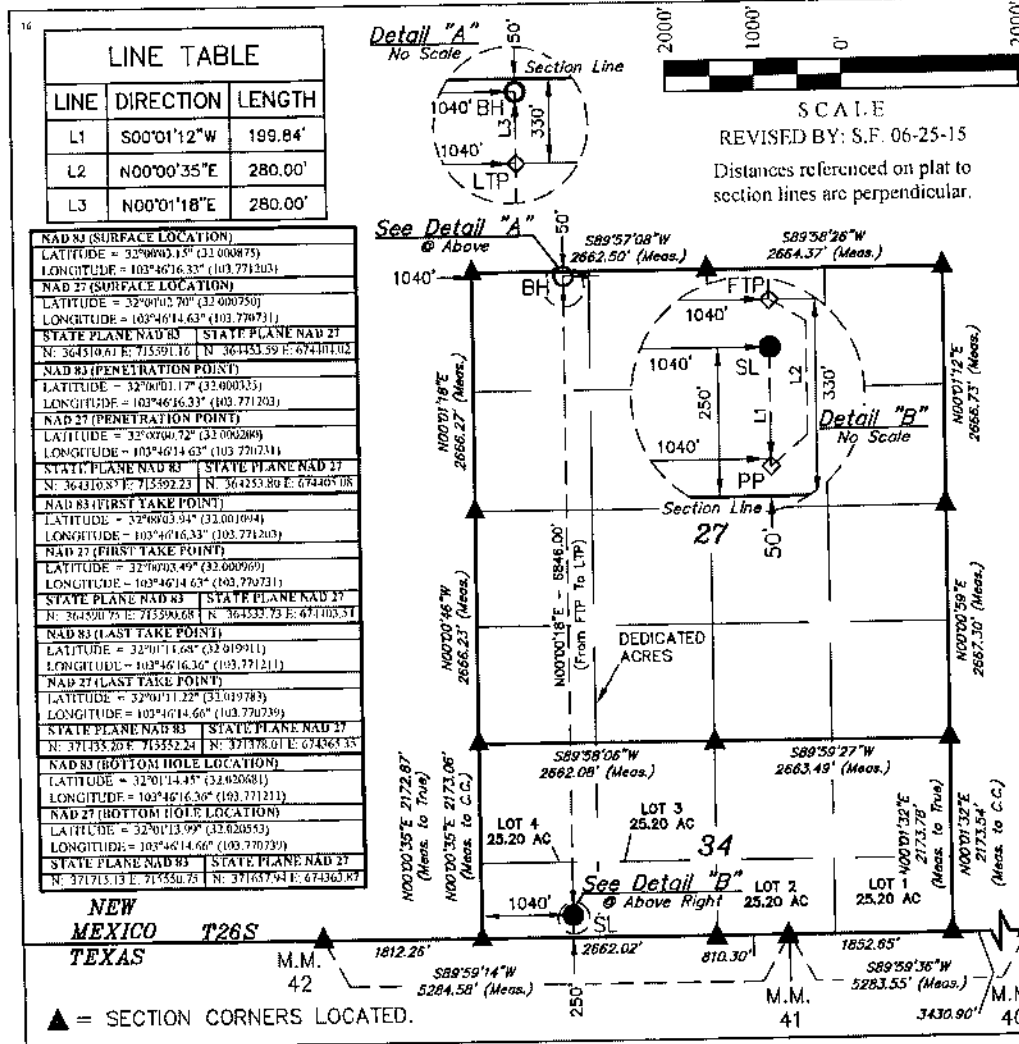
