Matador Production Company (OGRID No. 228937) seeks administrative approval of an unorthodox well location for its Charlie Sweeney 31-23S-28E RB #225H well (API No. pending) to be completed within the East Black River-Wolfcamp Gas Pool (Pool Code 97442) underlying the W/2 of Section 31, Township 23S, Range, 28E, Eddy County, New Mexico. Attached as **Exhibit A** is C-102 for the well. This is a horizontal well that will be drilled as follows:

**Charlie Sweeney 31-23S-28E RB #225H**

- **Surface Hole Location:** 492 feet from the South line and 587 feet from the West line of Section 30 Township 23 South, Range 28 East;
- **First Perforation Point:** 330 feet from the North line and 990 feet from the West line of Section 31, Township 23 South, Range 28 East;
- **Last Perforation Point:** 330 feet from the South line and 990 feet from the West line of Section 31; and
- **Bottom Hole Location:** 240 feet from the South line and 990 feet from the West line of Section 31.

Matador Production Company is requesting this NSL in order to efficiently produce its interests in Section 31. This well is producing from the East Black River-Wolfcamp Gas Pool (Pool Code 97442). There are no special pool rules for this pool, and thus the setback requirements under Rule 19.15.15.10(B) of 660' apply. As a result, the completed interval for this well is closer than 660' from the boundary of the project area. The unorthodox location will encroach towards the S/2 and NW/4 of Section 30 and the N/2 and SW/4 of Section 6, Township 24 South, Range 28 East. **Exhibit B** is list showing the surrounding ownership and the project area for the proposed Charlie Sweeney 31-23S-28E RB #225H well in relation to adjoining units.

**Exhibit C** is a list of the parties affected by the encroachment. Each of these parties have been provided notice of this application by certified mail, return receipt requested, advising them that if they have any objection to this well, it must be filed with the New Mexico Oil Conservation Division within 20 days of the mailing of this notice. In addition, a copy of this application has also been provided to the New Mexico State Land Office.
