

If a Watercourse was Impacted, Describe Fully.\*

Describe Cause of Problem and Remedial Action Taken.\*  
Lime Rock Resources was preparing to treat the well. When personnel arrived on location, the frac tanks containing hydrochloric acid were found to be leaking. Equipment was immediately transported to the location; a containment berm was constructed near the frac tanks. The frac tanks containing hydrochloric acid were emptied, the hydrochloride acid standing on location was neutralized using soda ash. After the free standing fluids were neutralized, the standing fluids were tested for pH level by Talon/LPE. The final pH level was reported to be 6.5.

Describe Area Affected and Cleanup Action Taken.\*  
The affected area was the location west of the frac tanks; the release fluids pooled near the frac tanks and then flowed across the location. The flow path was measured to be ninety-two (92') feet wide near the tanks and the flow path across location was measured to be one hundred fifty-two (152') feet long by twenty (20') feet to six (6') feet wide. The impacted area on the location was bladed using a backhoe and neutralized with soda ash.  
No further remediation actions will be required for the correction of release.
