Cimarex Energy Co. ("Cimarex") (OGRID No. 215099) is seeking administrative approval of an unorthodox well location ("NSL") for Triste Draw 25 Federal Com 25-23S-32E #11H well (API No. 30-025-43997) to be completed within the Triste Draw Bone Spring pool (Pool Code 96603) underlying the W/2 of the W/2 of Section 25, Township 23S, Range 32E, N.M.P.M., Lea County, New Mexico. A C-102 for the Well is attached as Exhibit A. This is a horizontal Well that will be drilled as follows:

Triste Draw 25 Federal Com 25-23S-32E #11H

- <u>Surface Hole Location</u>: 510 feet from the South line and 1140 feet from the West line of Section 25, Township 23 South, Range 32 East;
- <u>First Perforation Point</u>: 910 feet from the South line and 1110 feet from the West line of Section 25, Township 23 South, Range 32 East;
- <u>Last Perforation Point and Bottom Hole Location</u>: 330 feet from the North line and 1110 feet from West line of Section 25, Township 23 South, Range 32 East.

Cimarex is requesting this NSL in order to efficiently produce its interests in Section 25, and has included as Exhibit B a letter from an engineer explaining why this application is needed. The unorthodox location will encroach towards the E/2 of the W/2 of Section 25, Township 23 South, Range 32 East, and the SE/4 of the SW/4 of Section 24, Township 23 South, Range 32 East. A map showing the surrounding ownership and the project area for the proposed well in relation to adjoining spacing units is attached as Exhibit C.

A list of the parties affected by the encroachment is attached as Exhibit D. 

Cimarex Energy Co. respectfully requests administrative approval of the non-standard location application for the Triste Draw 25 Federal 11H, 12H & 13H wells.

Cimarex proposes to drill the Triste Draw 25 Federal 11H, 12H, & 13H wells as part of a six well development in the Avalon formation. Cimarex will drill these six wells from two drilling pads and have one central tank battery in order to prevent surface disturbance. The proposed wells will be testing 10 wells per section in the Upper Avalon and 10 wells per section in the Lower Avalon formation which is the tightest spacing tested to date, please see attached Exhibit A for additional information.

Cimarex expects to maximize the recoverable reserves by developing the West half of section 25 in the Upper & Lower Avalon at one time. The Triste Draw 25 Federal 13H is 290', the 12H is 40', and the 11H is 210' away from the West half West half quarter quarter line which allows Cimarex to properly space our Upper and Lower Avalon wells in order to maximize our recoverable reserves. Please see attached C102 for location and horizontal path of the referenced well.

The beneficial knowledge gained from the successful development of our Triste Draw Section 25 spacing pilot will help to determine maximum reserve recovery and possible drilling locations for additional Avalon development in this and other sections of our lease hold.



Section 25-23S-32E




