Commingled oil and gas production from the wells shall be measured and sold at the Grizzell "A" J.W. Boyd Central Tank Battery (CTB), located in Unit N of Section 5, Township 22 South, Range 37 East, NMPM, Lea County, New Mexico.

Production from the subject wells shall be determined as follows:

The oil and gas production from each of the diversely-owned leases shall be separately metered using a combination of well testing and allocation meters. Each well shall be tested monthly for a minimum of 24 hours. During the test, the remaining wells shall be shut-in as per the application.

The allocation meters shall be calibrated quarterly in accordance with Division Rule 19.15.12.10.C (2) NMAC.

This installation shall be installed and operated in accordance with the applicable Division Rules and Regulations.

The Operator shall notify the transporter of this commingling authority and the District Office prior to implementation of commingling operations.
