The combined project area for these wells includes the entire Section 20, Township 23 South, Range 34 East, NMPM, Lea County, New Mexico.

Production from the subject wells shall be determined as follows:

The oil production from the Stratocaster 20 Federal Well No. 1H and Stratocaster 20 Federal Well No. 2H shall be measured at, and sold from, Stratocaster 20 Federal Well No. 1H Central Tank Battery (Stratocaster 20 Federal Well No. 1H CTB) located in Unit M, Section 20, Township 23 South, Range 34 East, NMPM, Lea County, New Mexico, except when the CTB is over capacity, CTB is in repair, or the pipeline is in repair.

In any of these scenarios, the oil shall be transported to either the Red Hills Offload Station (Red Hills CTB) located in Unit O, Section 4, Township 26 South, Range 32 East, NMPM, Lea County, New Mexico, or the Jal Offload Station (Jal CTB) located in Unit D, Section 4, Township 26

South, Range 37 East, NMPM, Lea County, New Mexico. Further, the oil production from this lease shall not be commingled with production from any other lease or pool.

Gas production from the Stratocaster 20 Federal Well No. 1H and Stratocaster 20 Federal Well No. 2H shall measured separately at the Stratocaster 20 Federal Well No. 1H CTB before commingling at the gatherer's meter located in Unit G, Section 16, or the gatherer's meter located in Unit B, Section 29, all in Township 23 South, Range 34 East, NMPM, Lea County, New Mexico.

The oil production for the Stratocaster 20 Federal Well No. 3H and Stratocaster 20 Federal Well No. 4H shall be measured and sold at the Stratocaster 20 Federal Well No. 4H Central Tank Battery (Stratocaster 20 Federal Well No. 4H CTB), located in Unit I of Section 20, Township 23 South, Range 34 East, NMPM, Lea County, New Mexico, except when the CTB is over capacity, CTB is in repair, or the pipeline is in repair.

In any of these scenarios, the oil shall be transported to either the Red Hills CTB, or the Jal CTB. Further, the oil production from this lease shall not be commingled with production from any other lease or pool.

Gas production from the Stratocaster 20 Federal Well No. 3H and Stratocaster 20 Federal Well No. 4H shall measured separately at the Stratocaster 20 Federal Well No. 4H CTB before commingling at the gatherer's meter located in Unit G, Section 16, or the gatherer's meter located in Unit B, Section 29, all in Township 23 South, Range 34 East, NMPM, Lea County, New Mexico.

Your application has been duly filed under the provisions of Division Rules 19.15.12.10.C NMAC and 19.15.4.12.A (8) NMAC.

It is also understood that you have given due notice of this application to all owners in the mineral interest estate ("affected parties") as defined in Rule 19.15.12.10.C (4) NMAC.

The allocation meters shall be calibrated quarterly in accordance with Rule 19.15.12.10.C (2) NMAC.

This installation shall be installed and operated in accordance with the applicable Division Rules. It is the responsibility of the producer to notify the transporter of this commingling authority.

This administrative order is subject to like approval from the Bureau of Land Management.

The operator shall notify the Hobbs District office of the Division prior to implementation of the commingling operations.
