**Re: Application of EOG Resources, Inc. for administrative approval of an unorthodox well location for its Hawk 26 Fed No. 704H Well in the E/2 W/2 of Section 35, Township 24 South, Range 33 East, N.M.P.M., Lea County, New Mexico.**

Dear Ms. Riley:

EOG Resources, Inc. (OGRID No. 7377) seeks administrative approval of an unorthodox well location for its **Hawk 26 Fed No. 704H Well** (API No. 30-025-42397) to be completed within the WC-025 G-09 S243336I; Upper Wolfcamp Pool (98092) underlying Section 35, Township 24 South, Range 33 East, N.M.P.M., Lea County, New Mexico. This well will be drilled from a surface location 500 feet from the South line and 1,650 feet from the West line (Unit N) of Section 26. The upper most perforation will be located 50 feet from North line and 2,050 feet from the West line (Unit C) and the lower most perforation will be 330 feet from the South line and 2,050 feet from the West line (Unit N) of Section 35. Because this acreage is governed by the Division's statewide rules which provide for wells to be located no closer than 330 feet to the outer boundary of the spacing unit, the completed interval for this well will be unorthodox because it encroaches on the northern boundary of the project area.

EOG is the 100 percent working interest owner in the SE/4 SW/4 of Section 26, the spacing unit to the North. Approval of the unorthodox completed interval will allow EOG to use their preferred well spacing plan for horizontal wells in this area and thereby prevent waste.

**Exhibit A** is a draft Well Location and Acreage Dedication Plat (Form C-102), which shows that the completed interval of the proposed **Hawk 26 Fed No. 704H Well** encroaches on the spacing and proration unit to the North.

**Exhibit B** is a land plat for Section 35 and the surrounding sections that shows the proposed **Hawk 26 Fed No. 704H Well** in relation to adjoining units and existing wells.

**Exhibit C** is an affidavit from the landman verifying that ownership in the E/2 W/2 of Section 35 and the S/2 of Section 26 is identical. As described above, EOG is the 100 percent working interest owner in the E/2 W/2 of Section 35 and the SE/4 SW/4 of Section 26. Accordingly, there are no affected parties. A copy of this application has been provided to the Bureau of Land Management—Carlsbad Office.

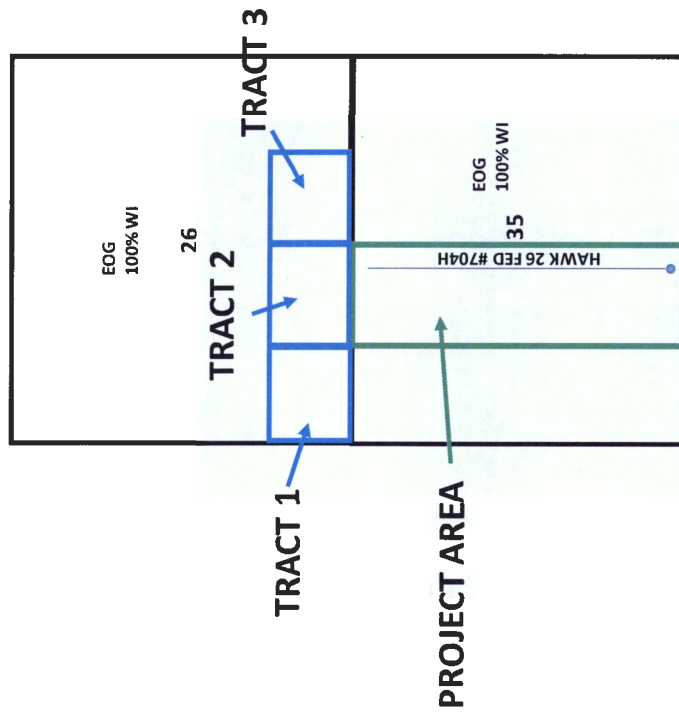


