Reference is made to your application received on February 28, 2018.

You have requested to drill this horizontal well at an unorthodox oil well location described above in the referenced pool or formation. This location is governed by statewide Rule 19.15.15.9.A NMAC, which provides for 40-acre units, with wells located at least 330 feet from a unit outer boundary.

This well's completed interval is less than 330 feet from the E/2 W/2 edge of Section 18 and the E/2 of the NW/4 of Section 19 project area and therefore will cause an encroachment toward the following tracts:

Section 18, encroachment to the E/2 W/2
Section 19, encroachment to the E/2 NW/4

It is our understanding that notice of this application to offsetting operators or owners is unnecessary due to common working interest.


