Percussion Petroleum Operating, LLC ("Percussion") (OGRID 371755) seeks administrative approval of an unorthodox location for its **Morris Boyd State Com No. 2H Well** (API No. 30-015-44670) to be completed in the N. Seven Rivers Glorieta Yeso Pool (Pool Code 97565) underlying Section 26, Township 19 South, Range 25 East, NMPM, Eddy County, New Mexico. This well will be drilled from a surface location 555 feet from the south line, 655 feet from the west line (Unit M) of Section 23. The upper most perforation will be located 100 feet from the north line, 360 feet from the west line (Unit D) of Section 26 and the lower most perforation will be 330 feet from the south line, 360 feet from the west line (Unit M) of Section 26. Since this acreage is governed by the Division's statewide rules which provide for wells to be located no closer than 330 feet to the outer boundary of the spacing unit, the completed interval for this well will be unorthodox because it encroaches on the northern and northwestern boundaries of the project area.

The SE/4 SE/4 of Section 22 and the SW/4 SW/4 of Section 23 will be developed by the Goodman 22 Nos. 5H and 7H wells (currently permitted). Approval of the unorthodox completed interval will allow Percussion to use their preferred well spacing plan for horizontal wells in this area and thereby prevent waste.

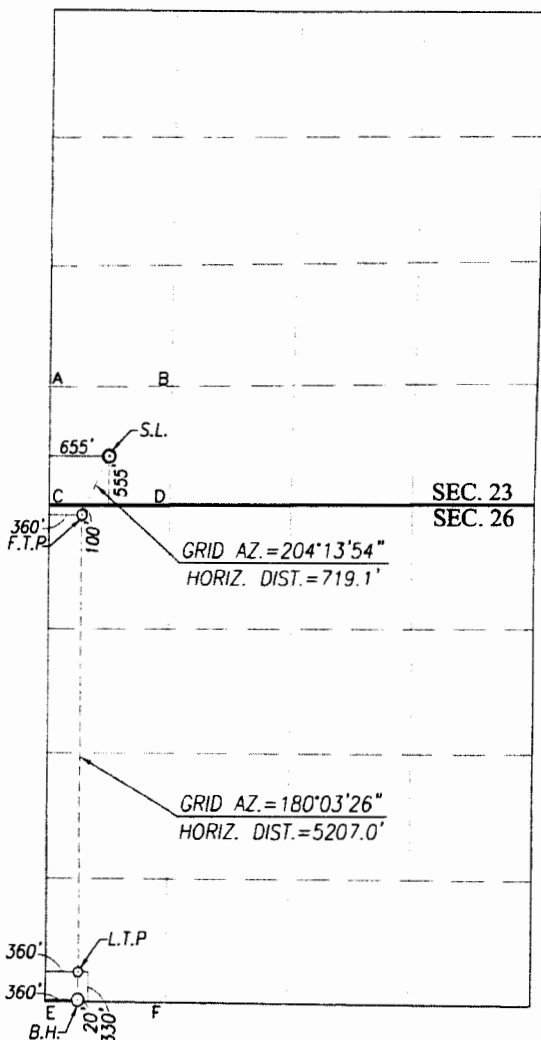

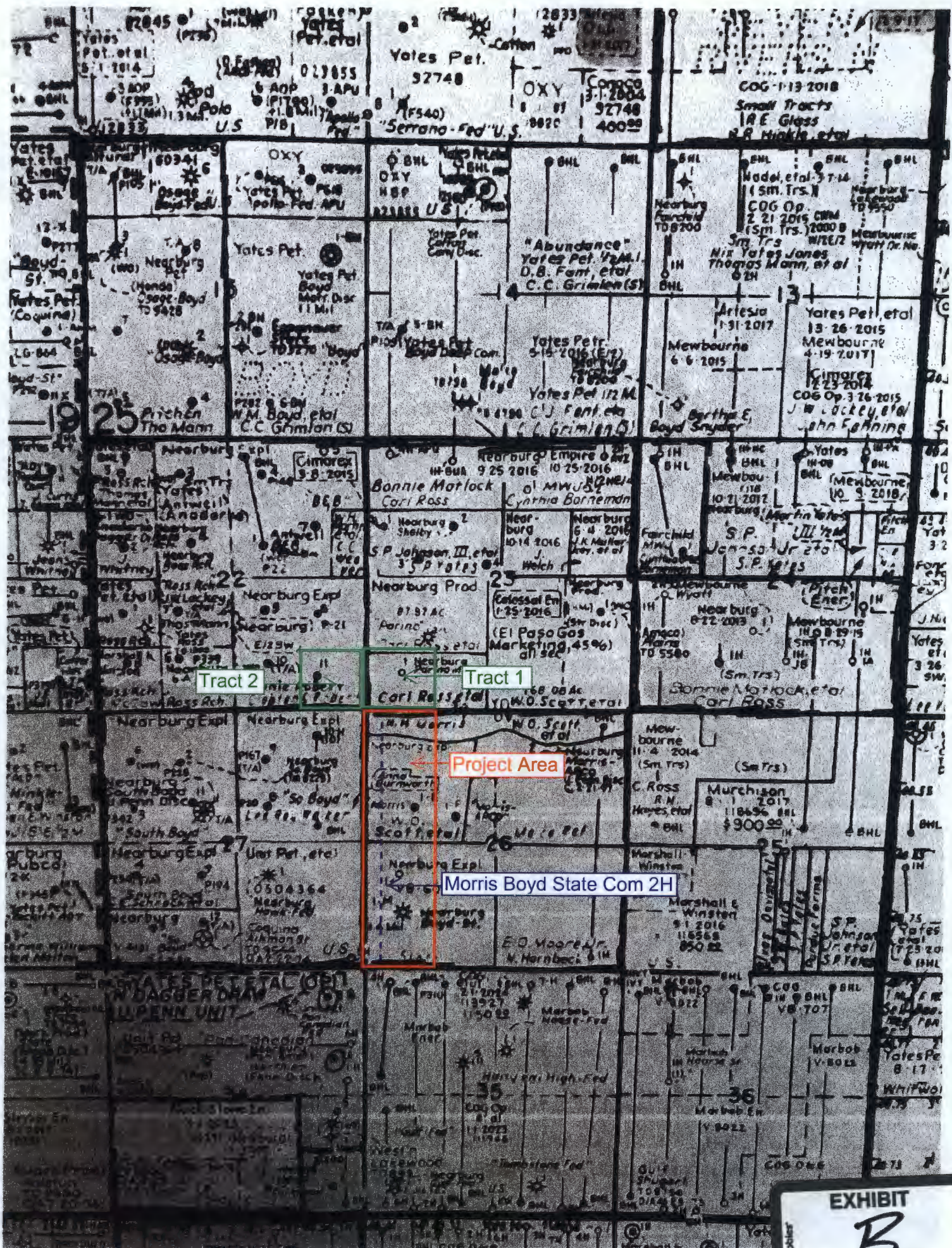
