Percussion Petroleum Operating, LLC ("Percussion") (OGRID 371755) seeks administrative approval of an unorthodox location for its **Morris Boyd State Com No. 5H Well** (API number pending) to be completed in the N. Seven Rivers Glorieta Yeso Pool (Pool Code 97565) underlying Section 26, Township 19 South, Range 25 East, NMPM, Eddy County, New Mexico. This well will be drilled from a surface location 555 feet from the south line, 1600 feet from the west line (Unit N) of Section 23. The upper most perforation will be located 100 feet from the north line, 1710 feet from the west line (Unit C) of Section 26 and the lower most perforation will be 330 feet from the south line, 1710 feet from the west line (Unit N) of Section 26. Since this acreage is governed by the Division's statewide rules which provide for wells to be located no closer than 330 feet to the outer boundary of the spacing unit, the completed interval for this well will be unorthodox because it encroaches on the northern and northwestern boundaries of the project area.

The S/2 SW/4 of Section 23 will be developed by the Goodman 22 Nos. 5H and 7H wells (currently permitted). Approval of the unorthodox completed interval will allow Percussion to use their preferred well spacing plan for horizontal wells in this area and thereby prevent waste.

Exhibit A is the Well Location and Acreage Dedication Plat (Form C-102), which shows that the completed interval of the proposed **Morris Boyd State Com No. 5H Well** encroaches on the spacing and proration units to the north and northwest.

Exhibit B is a land plat for Section 26 and the surrounding sections that shows the **Morris Boyd State Com No. 5H Well** in relation to the adjoining units and existing wells.

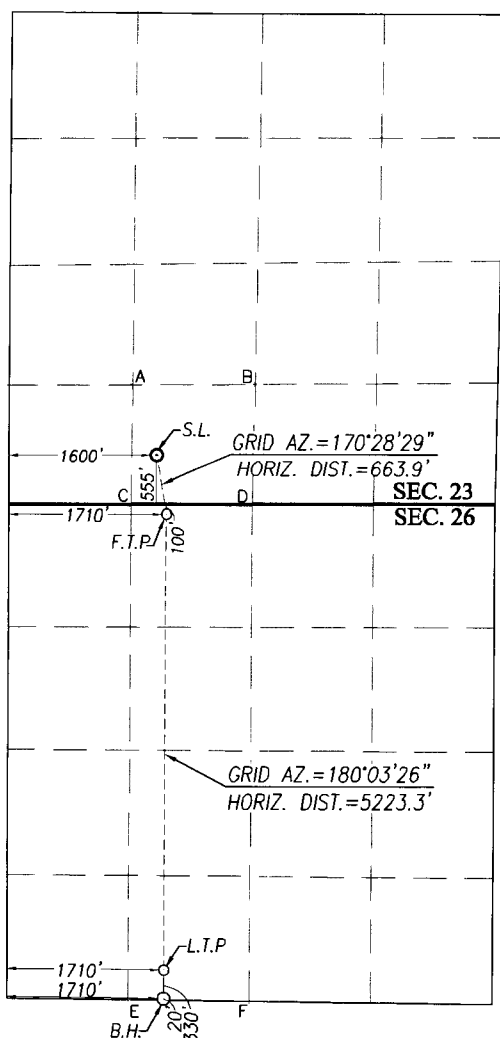

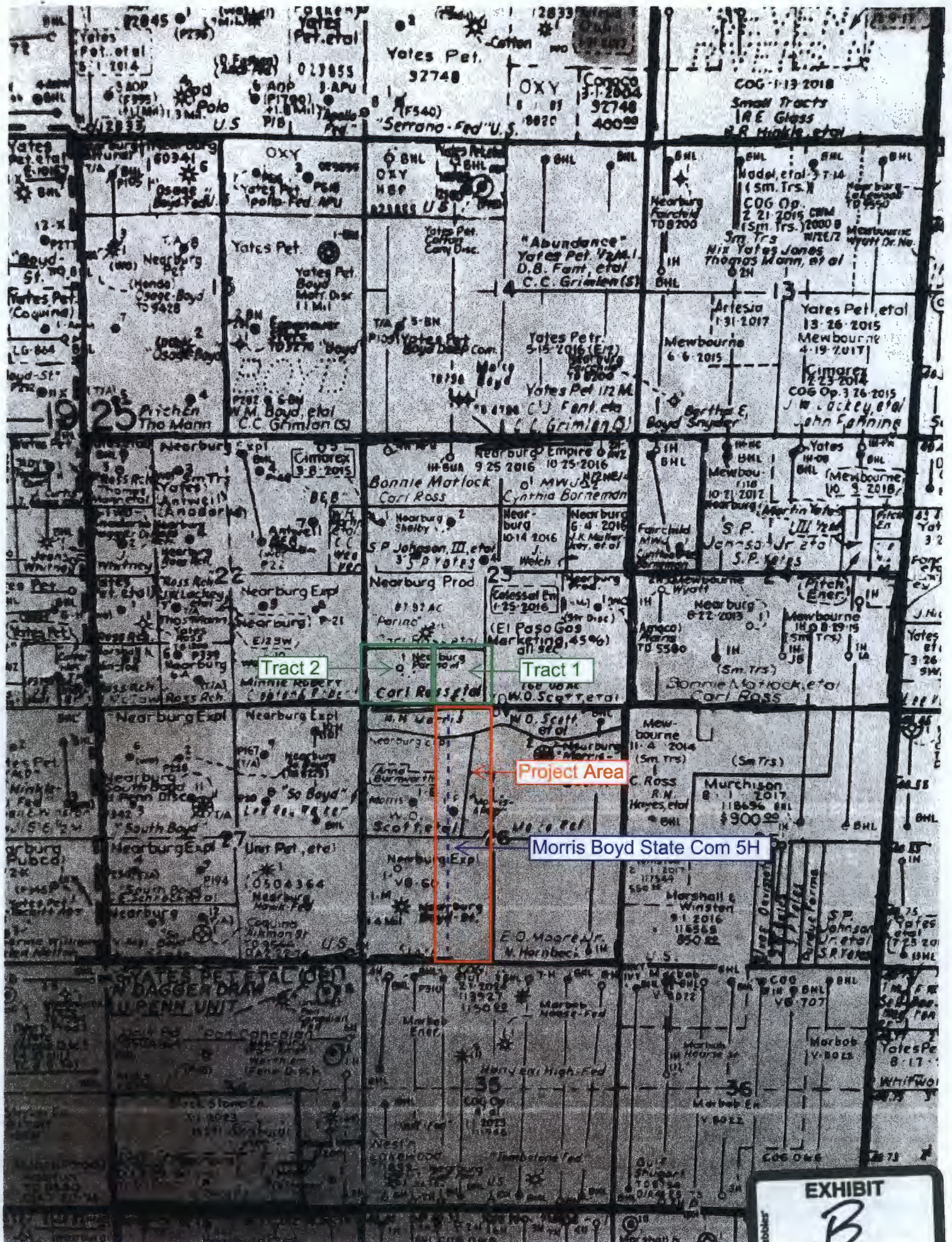
