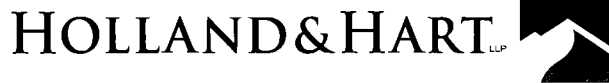

Centennial Resource Production, LLC ("Centennial") (OGRID No. 372165) seeks administrative approval of an unorthodox location for its **Horseshoe Fed Com No. 702H Well** (API number pending) to be completed in the Wolfcamp formation underlying the E/2 E/2 of Section 18, Township 21 South, Range 33 East, NMPM, Lea County, New Mexico. This well will be drilled from a surface location 300 feet from the north line, 645 feet from the east line (Unit A) of Section 19. The upper most perforation will be located 100 feet from the south line, 330 feet from the east line (Unit P) of Section 18 and the lower most perforation will be 100 feet from the north line, 330 feet from the east line (Unit A) of Section 18. Since this acreage is governed by the Division's statewide rules which provide for wells to be located no closer than 330 feet to the outer boundary of the spacing unit, the completed interval for this well will be unorthodox because it encroaches on the northern, northeastern, southern, and southeastern boundaries of the project area.

The purpose for the unorthodox locations at the first and last take points is to maximize the perforated lateral length and thereby capture reserves that may not otherwise not be recovered, without unreasonably infringing upon the correlative rights of the affected parties in the offsetting spacing units.
