I. This proposed Palmillo; Bone Spring, SW (96413) oil well (2nd Bone Spring sand) is on NM State Land Office (NMSLO) surface and NMSLO leases. Dedication is the 160 acres comprising the N2N2 15-19s-28e. Dedication is composed of 2 communitized NMSLO leases: 120 acre lease E0-5003-0005 and 9,166.42 acre lease X0-0648-0150. All surrounding leases are NMSLO leases (Exhibit A).

FTP is 100' and 431' from the closest dedication boundaries and 100' from the closest lease boundary. LTP is 100' and 430' from the closest dedication boundaries and 100' from the closest lease boundary. Exhibit B shows the lease boundaries as black dashed lines.

Apache requests a nonstandard location due to its goal of maximizing recovery and due to land uses, surface and subsurface, that makes wellbore geometry difficult. There are 2 pipeline rights-of-way (Enterprise crude oil line & DCP gas line), 2 CVE power line right-of-way, 1 county road right-of-way, 2 oil wells, frac pond, and on-lease non-right-of-way lines associated with Stephens & Johnson's East Millman Unit waterflood in D-14-19s-28e (see Exhibits C and D).

A standard location must be at least 330' from the dedication boundary. The take points are as close as 100' to the east and west dedication boundaries (see C-102 as EXHIBIT E). This places the take points 230' outside the standard drilling window. They are too far east and west.

II. Form C-102 showing the well and 160-acre dedication (N2N2 15-19s-28e) is attached as EXHIBIT E.

Apache operates the Bone Spring dedication bordering on the south of the proposed dedication (EXHIBIT F). No Bone Spring dedication borders on any other side or corner.

III. Encroachment to the east and west is toward State leases. One existing Bone Spring dedication (30-015-44668) touches the proposed dedication and it is Apache operated. This information is current and correct.

IV. See EXHIBIT F for the proposed well, dedications, and wells. Apache does not believe moving the take points to standard locations is cost effective for this well.

V. There are numerous manmade land use constraints (EXHIBITS C and D).

VI. Archaeology is not an issue.

VII. I hereby attest that I, on or before the date that the application was submitted to the division, sent notification to the affected persons (EXHIBIT G) by certified mail, return receipt requested, advising them that if they have an objection it must be filed in writing within 20 days from the date the division receives the application.
