Centennial Resource Production, LLC (OGRID 372165) seeks administrative approval of an unorthodox well location for its **Tour Bus 23 State Com No. 302H Well** (API No. Pending) to be completed within the Ojo Chiso; Bone Spring (Pool No. 96553) underlying Section 23, Township 22 South, Range 34 East, Lea County, New Mexico. This well will be drilled from a surface location 245 feet from the north line and 1,545 feet from the west line (Unit C) of Section 23. The upper most perforation will be located 350 feet from the north line and 1,650 feet from the west line (Unit C) and the lower most perforation point will be located 100 feet from the south line and 1,650 feet from the west line (Unit N). Since this acreage is governed by the Division's statewide rules which provide for wells to be located no closer than 330 feet to the outer boundary of the spacing unit, the completed interval for this well will be unorthodox because it is closer than 330 feet to the southwestern and southern boundaries of the project area.

Approval of the unorthodox completed interval will allow Centennial to use their preferred well spacing plan for horizontal wells in this area and thereby prevent waste.

Exhibit A is the Well Location and Acreage Dedication Plat (Form C-102), which shows that the completed interval of the proposed **Tour Bus 23 State Com No. 302H Well** encroaches on the spacing and proration units to the southwest and south.

Exhibit B is a land plat for Section 23 and the surrounding sections that shows the **Tour Bus 23 State Com No. 302H Well** in relation to adjoining units and existing wells.

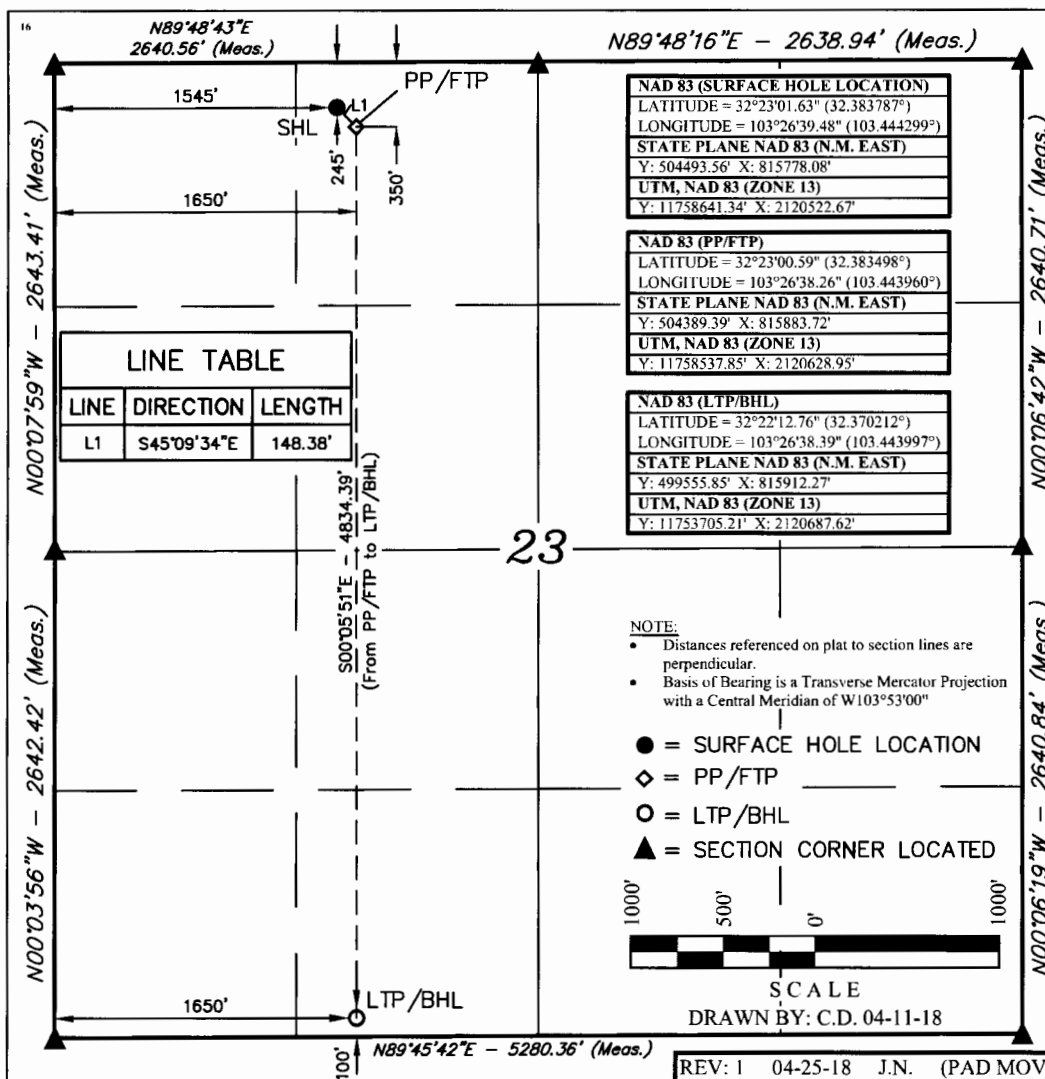

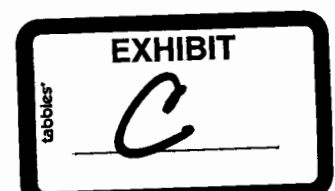
