Production from the subject wells shall be determined as follows:

The oil production from the Road Runner Federal Com Well No. 1H and Road Runner Federal Com Well No. 11H shall be measured separately at, and sold from, Road Runner Federal Com Well No. 1H and Road Runner Federal Com Well No. 11H Central Tank Battery (Road Runner Federal Com Well No. 1H CTB) located in Unit O, Section 25, Township 25 South, Range 26 East, NMPM, Eddy County, New Mexico, except when the CTB is over capacity, CTB is in repair, or the pipeline is in repair.

The oil production from the Road Runner Federal Com Well No. 2H and Road Runner Federal Com Well No. 12H shall be measured separately at, and sold from, Road Runner Federal Com Well No. 2H and Road Runner Federal Com Well No. 12H Central Tank Battery (Road Runner Federal Com Well No. 2H CTB) located in Unit O, Section 25, Township 25 South, Range 26

East, NMPM, Eddy County, New Mexico, except when the CTB is over capacity, CTB is in repair, or the pipeline is in repair.

In any of these scenarios, the oil shall be transported to either the Red Hills Offload Station (Red Hills CTB) located in Unit O, Section 4, Township 26 South, Range 32 East, NMPM, Eddy County, New Mexico, or the Jal Offload Station (Jal CTB) located in Unit D, Section 4, Township 26 South, Range 37 East, NMPM, Eddy County, New Mexico. Further, the oil production from either of these leases shall not be commingled with production from any other lease or pool, when either the Red Hills CTB or Jal CTB is utilized.

Gas production from the Road Runner Federal Com Well No. 1H and Road Runner Federal Com Well No. 11H shall measured separately at the Road Runner Federal Com Well No. 1 CTB before commingling at the gatherer's meter. Gas production from the Road Runner Federal Com Well No. 2H and Road Runner Federal Com Well No. 12H shall measured separately at the Road Runner Federal Com Well No. 2 CTB before commingling at the gatherer's meter. The gatherer's meter is located in O, Section 25, Township 25 South, Range 26 East, NMPM, Eddy County, New Mexico

Your application has been duly filed under the provisions of Division Rules 19.15.12.10.C NMAC and 19.15.4.12.A (8) NMAC.

It is also understood that you have given due notice of this application to all owners in the mineral interest estate ("affected parties") as defined in Rule 19.15.12.10.C (4) NMAC.

The allocation meters shall be calibrated quarterly in accordance with Rule 19.15.12.10.C (2) NMAC.

This installation shall be installed and operated in accordance with the applicable Division Rules. It is the responsibility of the producer to notify the transporter of this commingling authority.

This administrative order supersedes Administrative Order OLM-133, issued on February 14, 2018. This order approved commingling of two leases.

This administrative order is subject to like approval from the Bureau of Land Management.

The operator shall notify the Artesia District office of the Division prior to implementation of the commingling operations.
