Apache Corporation (OGRID 873) is hereby authorized to surface commingle oil and gas production and off-lease measure from diversely owned leases and wells identified in Attachment A and made part of this order. These wells and leases produce from Artesia; Glorieta-Yeso (O) Pool (Pool code 96830) and are located on State leases located in Section 32, Township 17 South, Range 28 East, Eddy County, New Mexico.

Production from the subject wells shall be determined as follows:

The commingled oil and gas production from the wells detailed above shall be measured and sold at the AB-647 Central Tank Battery (CTB), located in Unit N, Section 32, Township 17 South, Range 28 East, NMPM, Eddy County, New Mexico.

Oil and gas production from the AB Lease wells shall be measured with a combination of metering and well testing before commingling. Oil and gas production from the AA Lease shall be continuously measured before commingling.

The operator shall notify the transporter of this commingling authority.

Subsequent wells within leases approved by this order may be added to this administrative surface commingle application with a Sundry notice to the Engineering Bureau.

The operator shall notify the Artesia district office of the Division upon commencement of commingling operations.
