ADMINISTRATIVE CENTRAL TANK BATTERY ORDER

Administrative Order CTB-887

Mack Energy Corporation
Attn: Mr. Jerry Sherrell

Mack Energy Corporation (OGRID 13837) is hereby authorized to surface commingle gas production from diversely owned leases and wells identified in Attachment A, and made part of this order. These wells and leases produce from Round Tank; San Andres (Pool code 52770) and are located on Federal and State leases in Township 15 South, Range 28 and 29 East, Chaves County, New Mexico.

Production from the subject wells shall be determined as follows:

The gas production from wells in Attachment A shall be sold at the Facility Measurement Point (FMP) located in Unit O, Section 4, Township 16 South, Range 29 East, NMPM, Eddy County New Mexico.

The oil and gas production from each of the diversely-owned leases shall be measured with a combination of metering and well testing. Each of the wells shall be tested a minimum of seven days per cycle. The oil production from each well shall be measured and sold at each surface facility listed in Attachment A.

The operator shall notify the transporter of this commingling authority.

For future additions of wells and leases to this commingling operation, notice shall only be given to those interest owners in the wells and leases to be added, in accordance with Division Rule 19.15.12.10 C (4) (g) NMAC.

Subsequent wells within leases approved by this order may be added to this administrative surface commingle application with a Sundry notice to the Engineering Bureau.

This administrative order supersedes any previous administrative order for gas measurement only for wells listed in Attachment A.

Further, this administrative order supersedes Administrative Order CTB-855, issued on May 8, 2018. This administrative order adds new dedicated acreage and additional wells.

The operator shall notify the Artesia district office of the Division upon commencement of commingling operations.

This approval is subject to like approval from the **Bureau of Land Management** and **New Mexico State Land Office** before commencement of the commingling operations.
