Marathon Oil Permian LLC ("Marathon"), OGRID Number 372098, is seeking administrative approval of an unorthodox well location ("NSL") for the **Tiberius 33 WXY FC 10H** well (the "Well") to be completed within the Purple Sage; Wolfcamp (Gas) (Pool Code 98220) underlying the N/2 S/2, Sections 32 and 33, Township 22 South, Range 28 East, N.M.P.M., Eddy County, New Mexico. A C-102 for the Well is attached as Exhibit A. This is a horizontal well that will be drilled as follows:

- Surface Hole Location: 1410' from the South Line and 420' from the East Line of Section 33, Township 22 South, Range 28 East, N.M.P.M., Eddy County, New Mexico;
- First Take Point: 2304' from the South Line and 100' from the East line of Section 33;
- Last Take Point and Bottom Hole Location: 2314' from the South Line and 100' from the West line of Section 32, Township 22 South, Range 28 East, N.M.P.M., Eddy County, New Mexico.

Marathon has included as Exhibit B a letter explaining why this application is needed. This well will produce from the Purple Sage; Wolfcamp (Gas) (Pool Code 98220). There are special pool rules for this pool under Order No. R-14262, that establish 330' foot setback requirements. The completed interval for the proposed well is closer than 330' from the boundary of the spacing unit.

The unorthodox location will encroach towards the SE/4 of Section 31, Township 22 South, Range 28 East and the SW/4 of Section 34, Township 22 South, Range 28 East. Marathon is providing notice to the working interest owners in the SE/4 of Section 31, Township 22 South, Range 28 East and the SW/4 of Section 34, Township 22 South, Range 28 East, as shown in Exhibit C. For information purposes, working ownership is the same for the entire E/2 of Section 31 (with the exception of the NWNE, where Marathon has 100%) and the entire W/2 of Section 34. Marathon also provides a midland map of this area, attached as Exhibit D. Marathon has confirmed that the tracts adjoining the spacing unit by a corner are more the 330' away from the unorthodox locations requested. Proof of mailing is attached hereto as Exhibit E.

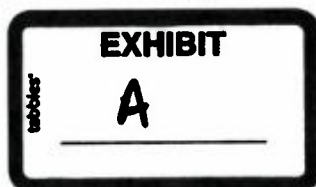

Marathon Oil Permian LLC respectfully requests administrative approval of the non-standard location for the Tiberius 33 WXY FC 10H well, to be drilled in Purple Sage; Wolfcamp (Gas) pool (98220). Marathon plans for this well to have a first take point at 100' FEL and 2360' FSL Section 33, and last take point at 100' FWL and 2360' FSL Section 32, which is closer to the unit line than allowed under the subject field rules. Marathon requests this non-standard location because the placement conforms to the first and last take points of the other wells in the section. This spacing best fits into the spacing for the other wells in the development plan of the entire section and we believe that it will result in the greatest recovery of reserves.
