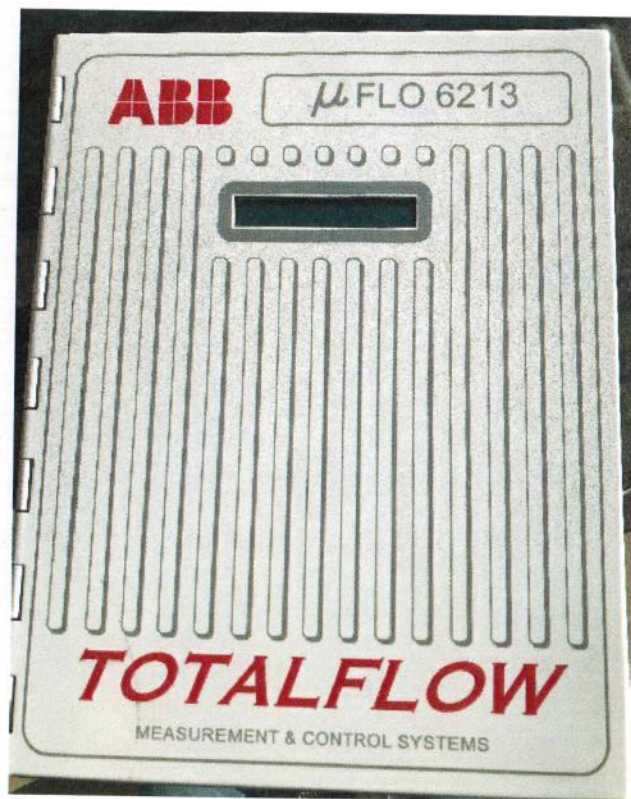

Surface Commingle Project

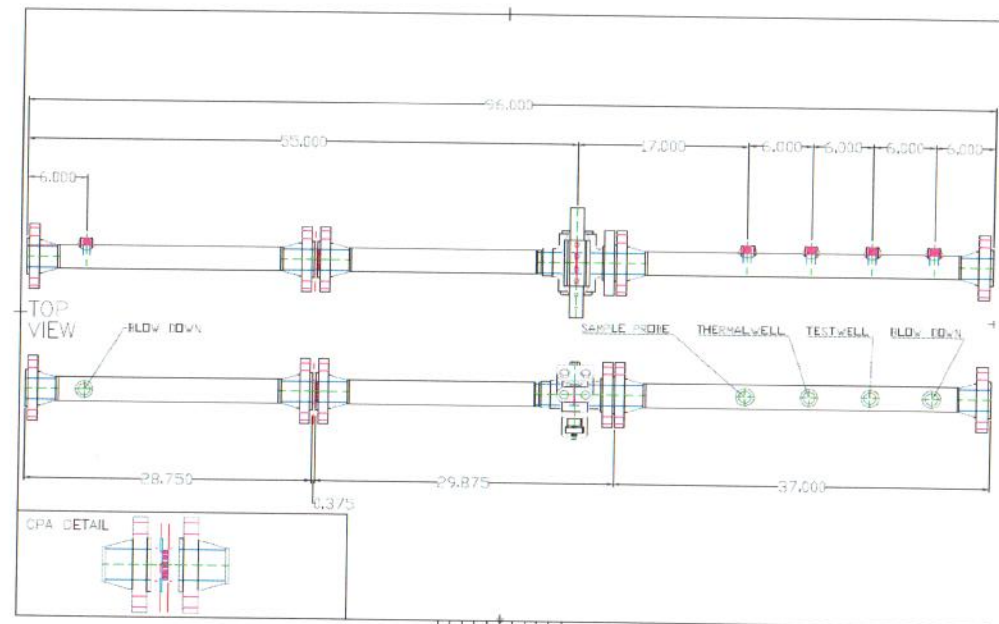
The purpose of Mustang's Surface Commingle Project is to prevent premature abandonment of low pressure and volume wells based on economic conditions and to reduce excess compressor engine emissions. We plan on conducting a flow test to determine if volumes will warrant installing permanent facilities and prevent premature abandonment. All measurement facilities will be installed to BLM guidelines. The project will include the following:

1. Install new 2" meter tube, with JR fitting, prior to suction of existing compressor on adjacent well pad.
2. Install TOTALFLOW ABB μ FLO6213 EFM meter with solar power, calibrated to BLM Specs.
3. Wells are completed in different intervals with different spacing allocations. TOTAL FLOW allocation meters will be utilized to calculate volume at the wellhead. Existing Williams or Enterprise meter will be used as CDP to measure total compressed and measured volume.
4. Piping installed will be 2" SDR7 Poly lines, buried only where traffic would cross over lines. Existing lines will be utilized as much as possible.
5. All facilities will be installed on Lease and within existing well pad or existing ROW's.

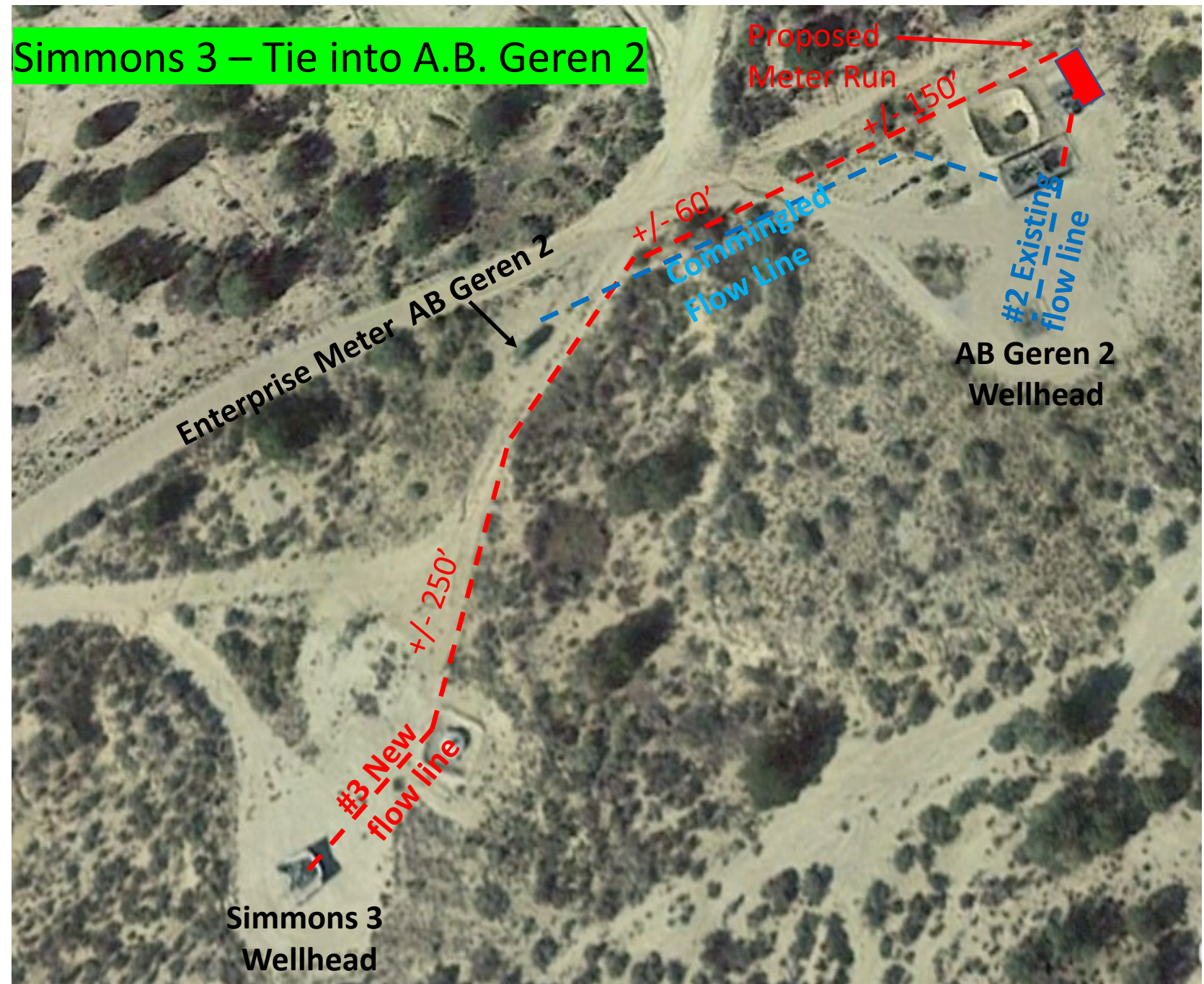

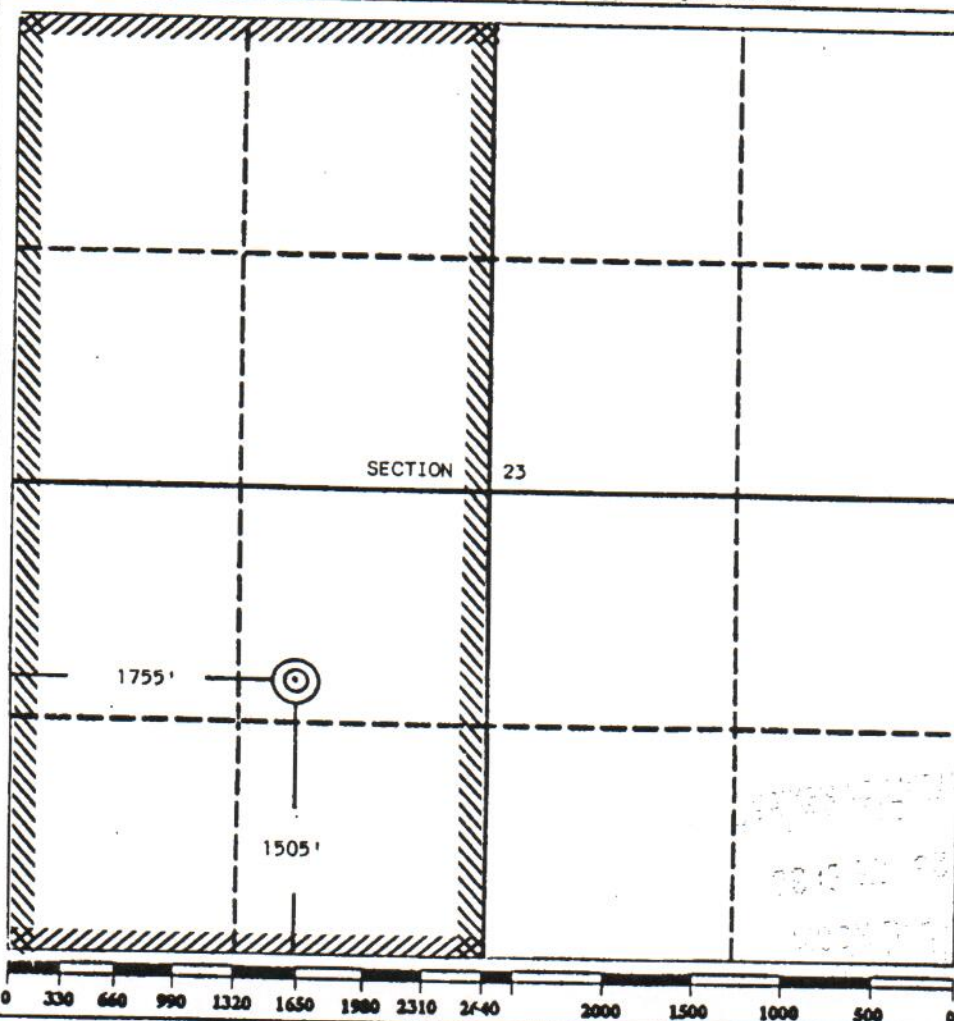

Mustang Resources, LLC ("Mustang") is the new/current Operator of the Simmons #3, #4 and #5 wells located San Juan County, NM. Mustang will be initiating a Surface Commingle Project, which includes the above described wells, with the purpose of preventing premature abandonment of these low pressure/volume wells while reducing excess compressor engine emissions.

To optimize the performance of the wells, Mustang will be conducting the following operations:

- 1) Simmons #3: Tie into the A.B Geren 2 existing compressor; add new meter so production from each well is monitored separately; proposed line will be within existing ROW's or on well pad(s).
- 2) Simmons #4: Tie into the Simmons E2A existing compressor; add new meter so production from each well is monitored separately; proposed line will be within existing ROW's or on well pad(s).
- 3) Simmons #5: Tie into the Simmons E3C existing compressor; add new meter so production from each well is monitored separately; proposed line will be within existing ROW's or on well pad(s).
