Oil & Gas & Water Metering and Allocation Methods:

Each well will have all three phases measured before being comingled.

- The gas will be measured off of a separator by an orifice meter and then be sent to a common sales line or a common flare.
- The water will be measured off of a separator by a MAG meter and sent to a common tank battery where it will be shipped to a SWD.
- The oil will be measured off of a treater by a Coriolis meter and sent to a common tank battery where it will be sold by truck.
- The gas off of the treater will be measured by an orifice meter and sent to a common flare.
- The tank vapors from the common tank battery will be estimated and sent to a common flare.

Process and Flow Descriptions:

General Well Flow

General Well Flow

All gross production from the well flow from its respective wellhead through a 3 – phase flowline to the tank battery. At the tank battery it flows through a dedicated 3-phase separator which meters water and

gas. The water is comingled and stored in tanks. The gas is comingled and sold through a pad sales meter. The oil is sent to a dedicated heater treater and is measured before being comingled and stored in tanks. Any hydrocarbon liquid collected from gas scrubbers will be sold from the tanks as oil.

Oil

Gross production of oil is measured at the outlet of the dedicated heater treater using a Coriolis meter. The oil is then comingled and flows to the common tanks where it is sold by truck from loading points on the tanks, the oil is measured by tank gauging. The water from the heater treater is sent to the common water storage tanks.

Gas

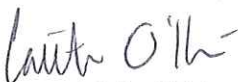
Gross production of the gas is measured at the outlet of the dedicated separator using an orifice meter. The gas will then be comingled and flow through the gas sales orifice meter on the pad. If gathering pressures are too high the gas will flow through an orifice flare meter and comingle before flowing to a high pressure flare. All flash gas from the treater will be measured using an orifice meter and sent to a common flare. Tank vent emissions are routed to a low pressure flare.

Water

Gross production of water is measured at the outlet of the dedicated separator using a MAG meter. The water is comingled and sent to common storage tanks. From the tanks, the water is sent to a pump and measured using a turbine meter. The pump moves the water to a Salt Water Disposal well.

RKI EXPLORATION & PRODUCTION, LLC understands the requested approval will not constitute the granting of any right-of-way or construction rights not granted by the lease instrument. These applications will be submitted separately for approval per NMOCD regulations.

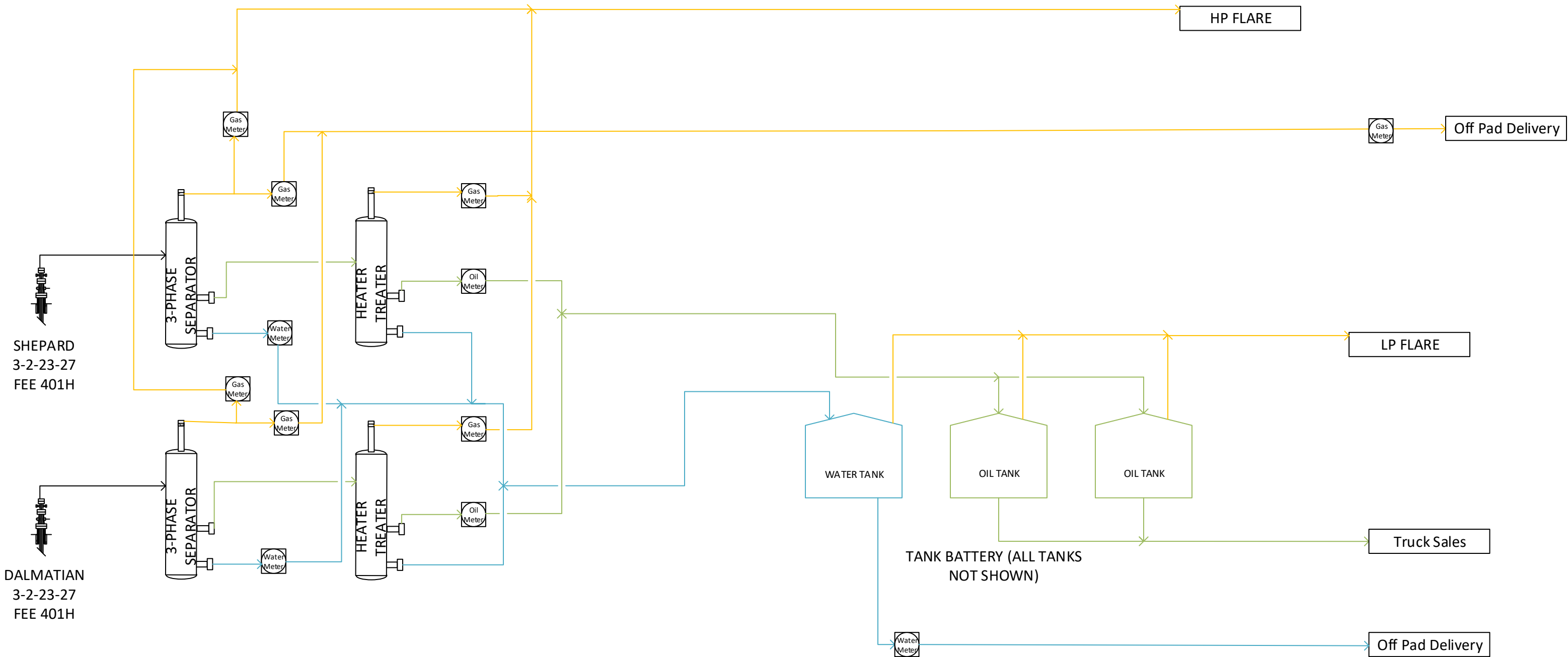

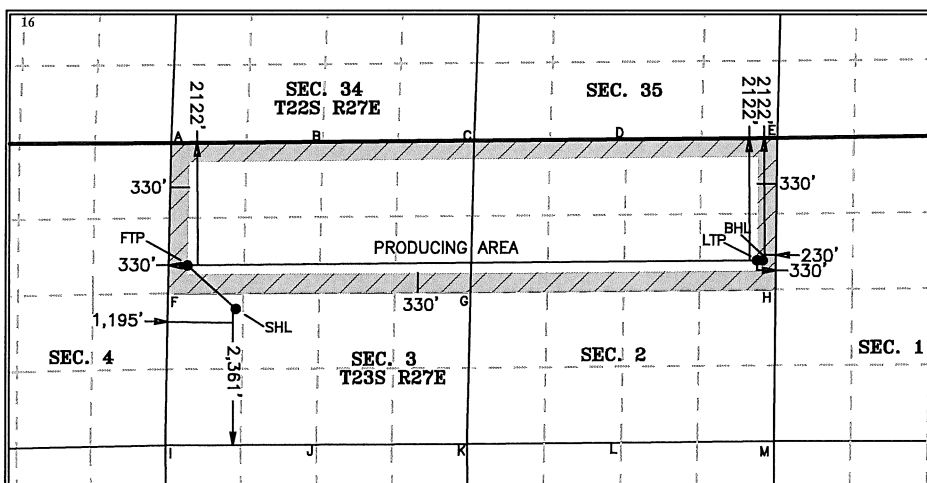
