Your applications for the Simmons Well No.3, Simmons Well No.4, Simmons No. 5, and LV Hammer B Well No. 1 have been suspended.

Your measurement description for all of the applications was not clear.

Based on previous conversations, I believed the wells were being continuously metered. However, later I discovered the wells will be measured with a combination of metering, well testing, and historical production.

You must renotify all affected parties with a better description of measurement method.

Look at Administrative Order PLC-498 to get an idea of how XTO requested metering and well testing..
