EOG Resources, Inc. (OGRID No. 7377) seeks to amend the administrative approval granted in NSL-7863, authorizing an unorthodox well location for its **Savage 2 State Com No. 505H Well** (API No. Pending) within the WC-025 F-07 S243225C; Lower Bone Spring Pool (97964) underlying Lot 3 and the SE/4NW/4, E/2SW/4 (i.e., E/2W/2) of Section 2, Township 25 South, Range 32 East, N.M.P.M., Lea County, New Mexico.

NSL-7863 authorized EOG to drill its well at the following location:

EOG encountered an issue while drilling this well, requiring the rig to be skidded to drill from a new surface location. Consequently, a new name and API number have been assigned to this well and the surface location has been revised, as depicted in the C-102 filed with the Division. As reflected in the as-drilled directional survey, attached as **Exhibit A**, the surface location is 472 feet from the north line and 2,211 feet from the east line of Section 2, Township 25 South, Range 32 East, Lea County, New Mexico. The first take point is 100 feet from the north line 2,398 from the west line of Section 3, Township 25 South, Range 32 East, Lea County. The last take point is 123 feet from the south line and 2,527 feet from the west line of Section 3, Township 25 South, Range 32 East, Lea County.

The as-drilled well path is thus within the 50-foot allowance permitted under Rule 19.15.16.15(C)(d) NMAC and is no closer to the outer boundary of the spacing unit than authorized under NSL-7863.

Accordingly, we ask the Division to amend NSL-7863 to reflect the applicable well name and API number subject to NSL-7863. The well name has been revised to the **Savage 2 State Com No. 505Y Well** with an API number of 30-025-45814.

Each of the parties listed on **Exhibit C** to the original application have been provided notice of this application by certified mail. A copy of this application has been provided to the State Land Office.


