Re: Application of Marathon Oil Permian LLC for administrative approval of unorthodox well location for its Achilles 8 WXY Fed Com 5H well, located in the E/2 of Section 5, Township 23 South, Range 28 East, N.M.P.M., Eddy County, New Mexico.

Dear Director Sandoval:

Marathon Oil Permian LLC ("Marathon"), OGRID Number 372098, is seeking administrative approval of an unorthodox well location ("NSL") for the **Achilles 8 WXY FC 5H well** (the "Well") to be completed within the Purple Sage; Wolfcamp (Gas) (Pool Code 98220) underlying the E/2 of Section 5, Township 23 South, Range 28 East, N.M.P.M., Eddy County, New Mexico. A C-102 for the Well is attached as Exhibit A. This is a horizontal well that will be drilled as follows:

- Surface Hole Location: 905' from the South Line and 1220' from the East Line of Section 5, Township 23 South, Range 28 East, N.M.P.M., Eddy County, New Mexico;
- First Take Point: 100' from the South Line and 1656' from the East line of Section 5;
- Last Take Point and Bottom Hole Location: 100' from the North Line and 1676' from the East line of Section 5, Township 23 South, Range 28 East, N.M.P.M., Eddy County, New Mexico.

Marathon has included as Exhibit B a letter explaining why this application is needed. This well will produce from the Purple Sage; Wolfcamp (Gas) (Pool Code 98220). There are special pool rules for this pool under Order No. R-14262, that establish 330' foot setback requirements. The completed interval for the proposed well is closer than 330' from the boundary of the spacing unit.

The unorthodox location will encroach towards (1) the SE/4 of Section 32, Township 22 South, Range 28 East, and (2) the NE/4 of Section 8, Township 23 South, Range 28 East. Marathon is providing notice to the working interest owners in the SE/4 of Section 32, Township 22 South, Range 28 East, and the NE/4 of Section 8, Township 23 South, Range 28 East, as shown in Exhibit C. Marathon also provides a midland map of this area, attached as Exhibit D. Marathon has confirmed that the tracts adjoining the spacing unit by a corner are more than 330' away from the unorthodox locations requested. Proof of mailing is attached hereto as Exhibit E.

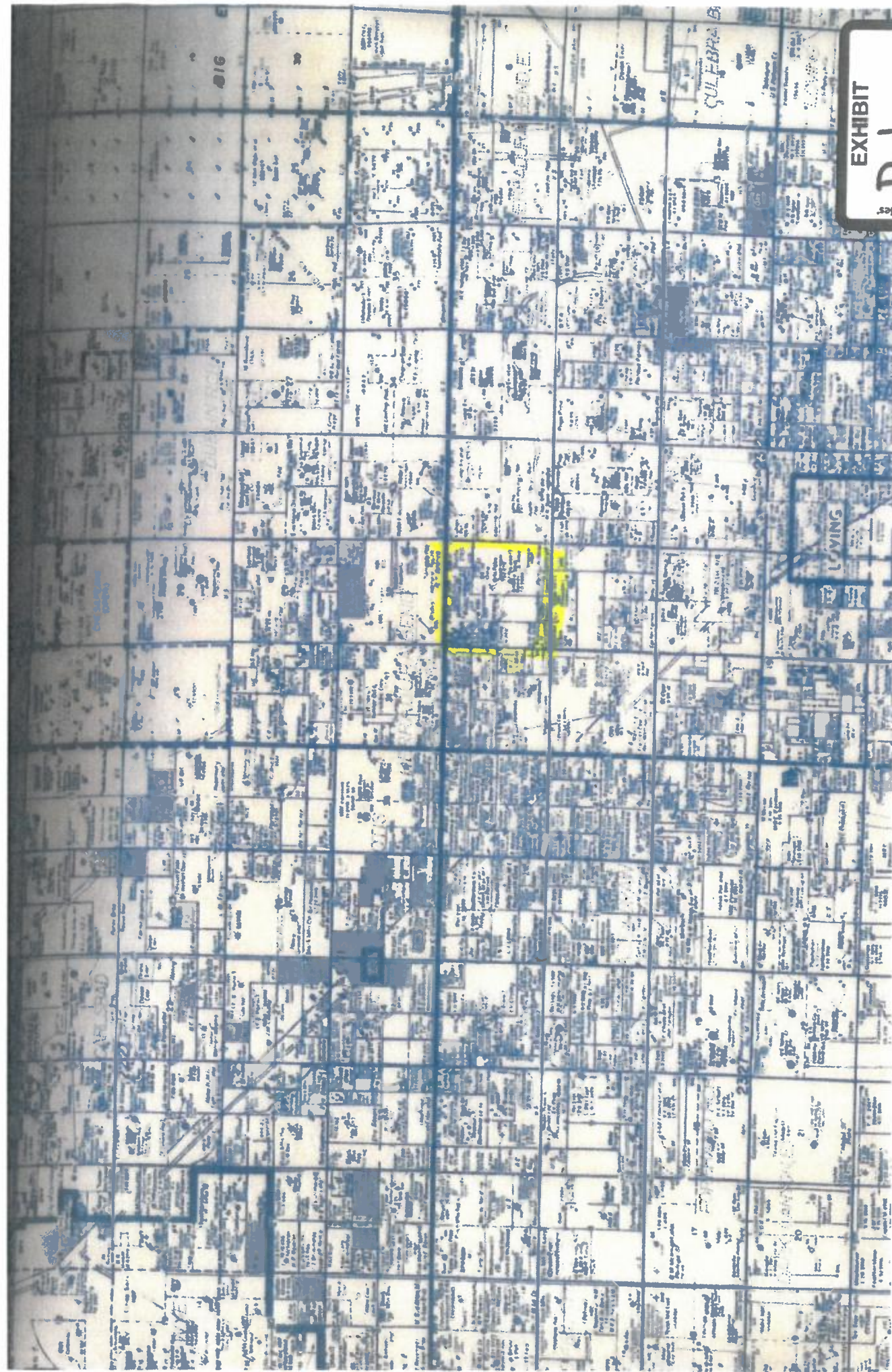
