Pursuant to your application received on May 31, 2019, Mustang Resources LLC (OGRID 373495) is hereby authorized to surface commingle gas production from the following pools located in Section 24, Township 29 North, Range 9 West, NMPM, San Juan County, New Mexico;

The commingled gas production from the wells detailed above shall be measured and sold at the Simmons E Well No. 3 C Central Tank Battery (CDP) located in Lot 5/ Unit E of Section 24, Township 29 North, Range 9 West, NMPM, San Juan County, New Mexico.

Production from the subject wells shall be determined as follows:

The wells shall be measured with a combination of metering and subtraction Simmons E Well No. 3 C shall be metered continuously prior to commingling with the Simmons Well No. 3 C. Production from the Simmons Well No. 5 shall be determined by subtracting the metered production at the CDP minus the metered production at the Simmons E Well No. 3 C.

The allocation meters shall be calibrated quarterly in accordance with Division Rule 19.15.12.10.C (2) NMAC.

This installation shall be installed and operated in accordance with the applicable Division Rules and Regulations.

The Operator shall notify the transporter of this commingling authority and the District Office prior to implementation of commingling operations.

This administrative order is subject to like approval from the Bureau of Land Management.
