Marathon Oil Permian LLC ("Marathon"), OGRID Number 372098, is seeking administrative approval of an unorthodox well location ("NSL") for the **Neptune 8 WXY Fee 1H** well (the "Well") to be completed within the Purple Sage; Wolfcamp (Gas) (Pool Code 98220) underlying the W/2 Section 5, Township 23 South, Range 28 East, N.M.P.M., Eddy County, New Mexico. A C-102 for the Well is attached as Exhibit A. This is a horizontal well that will be drilled as follows:

- <u>Surface Hole Location</u>: 730' from the South Line and 1250' from the West Line of Section 5, Township 23 South, Range 28 East, N.M.P.M., Eddy County, New Mexico;
- <u>First Take Point</u>: 100' from the South Line and 2322' from the West line of Section 5;
- <u>Last Take Point and Bottom Hole Location</u>: 100' from the North Line and 2307' from the West line of Section 5, Township 23 South, Range 28 East, N.M.P.M., Eddy County, New Mexico.

Marathon has included as Exhibit B a letter explaining why this application is needed. This well will produce from the Purple Sage; Wolfcamp (Gas) (Pool Code 98220). There are special pool rules for this pool under Order No. R-14262, that establish 330' foot setback requirements. The completed interval for the proposed well is closer than 330' from the boundary of the spacing unit.

Marathon is providing notice to the working interest owners in the SW/4 of Section 32, Township 22 South, Range 28 East, and the NW/4 of Section 8, Township 23 South, Range 28 East, as shown in Exhibit C. Marathon also provides a midland map of this area, attached as Exhibit D. Marathon has confirmed that the tracts adjoining the spacing unit by a corner are more the 330' away from the unorthodox locations requested. Proof of mailing is attached hereto as Exhibit E.



Marathon Oil Permian LLC respectfully requests administrative approval of the non-standard location for the Neptune 8 WXY Fee 1H well, to be drilled in Purple Sage; Wolfcamp (Gas) pool (98220). Marathon plans for this well to have a first take point at 100' FSL and 2310' FWL of Section 5, and last take point at 100' FNL and 2310' FWL of Section 5, which is closer to the unit line than allowed under the subject field rules. 



