The proposed commercial operation will be for produced water disposal from area operators. As indicated in the notice below, the well is located in Section 11, Township 23 South, Range 34 East, Lea County, New Mexico.

The published notice states that the interval will be from 14,700 feet to 16,652 feet into the Silurian, Fusselman and Montoya Formations.
