NGL is submitting a protest of the following COG application:

LEGAL NOTICES MAY 18, 2019 COG Operating LLC, 2208 W. Main Street, Artesia, New Mexico, 88210, has filed Form C-108 (Application for Authorization to Inject) with the New Mexico Oil Conservation Division seeking administrative approval for a salt water disposal well. The proposed well, the Mortarboard 1 Fee SWD No. 1, is located 1605' FSL and 210' FWL, Section 1, Township 24 South, Range 34 East, Lea County, New Mexico. Disposal water will be sourced from area wells producing from the Delaware, Bone Spring and Wolfcamp formations. The disposal water will be injected into the Devonian/Silurian formation at an estimated depth of 15,000' to 16,800' at a maximum surface pressure of 3000 psi and a maximum rate of 40,000 BWPD. The proposed SWD well is located approximately 17.5 miles west/northwest of Jal. Any interested party who has an objection to this must give notice in writing to the Oil Conservation Division, 1220 South Saint Francis Street, Santa Fe, New Mexico, 87505, within fifteen (15) days of this notice.
