

A Street, Midland, TX 79705 for administrative approval for its proposed salt water disposal well Bench State SWD #1 ("Proposed Well"). The Proposed Well would be located within Section 6, Township 24 South, Range 35 East, Lea County, New Mexico. According to the public notice of the Application, disposal water will be injected into the Silurian, Fusselman and Montoya formations at a depth of 16,760 feet to 18,498 feet, with a maximum injection rate of 30,000 BWPD and a maximum surface injection pressure of 3,000 psi.
