I am submitting this objection on behalf of Intrepid Potash-New Mexico, LLC ("Intrepid New Mexico") to the referenced Application by Vista Disposal Solutions, LLC for Authorization to Inject ("Application").

The Application is for the Justin Federal SWD # 1 salt water disposal well on surface owned by the United States in SE/4NE/4 Section 25, Township 25 South, Range 34 East. Intrepid New Mexico is the assignee of a Grazing Permit issued by the BLM for that land and anticipates that the BLM will soon issue to Intrepid New Mexico a new Grazing Permit for the same land. Intrepid New Mexico also owns other real property in the vicinity of the land on which Vista Disposal wishes to drill, including the surface in portions of Section 24, Township 25 South, Range 34 East, less than half a mile from the land subject on which Vista Disposal wishes to drill.

In addition to this objection, Intrepid New Mexico also hereby requests a hearing on the Application.
