Marathon Oil Permian is in receipt of an Application to Inject from R.T. Hicks Consultants, LTD on behalf of AWR Disposal LLC for their Blue Hole SWD 1, location (Unit G) of Section 14, T23S, R34E in Lea County, NM.

Marathon has reviewed their Application and we believe that the location of the proposed Salt Water Disposal is within 1 mile of a fault of concern, therefore we would like to notify the Commission of our Protest.

AWR Disposal LLC, 3300 N. A Street, Ste. 220, Midland, TX 79705 filed Form C-108 (Application for Authorization to Inject) with the New Mexico Oil Conservation Division seeking administrative approval for a salt water disposal well. The proposed well, the Blue Hole SWD #1 will be located 978 feet from the South line and 2,383 feet from the West line, Section 14, Township 23 South, Range 34 East, Lea County, New Mexico. Produced water from area production will be commercially disposed into the Devonian, Fusselman and Montoya Formations at a depth of 14,462 feet to 16,489 feet at a maximum surface pressure of 3,000 psi and an average injection rate of 30,000 barrels per day. The proposed SWD well is located approximately 24.1 miles southwest of Eunice, New Mexico.
