OXY USA Inc. respectfully requests administrative approval of a non-standard location on the Oxbow CC 17-8 Federal Com 32H well, API Number-30-015-45084, Property Code 321633. The #32H well is proposed to be completed in the Purple Sage Wolfcamp pool, Pool Code 98220 which has special pool rules specifying the completed interval must be located 330 feet from the exterior boundary of the applicable spacing unit. The proposed completed interval is projected as follows:

First Take Point – 100' FSL 1260' FWL Unit M Sec 17 T24S R29E  
Last Take Point – 100' FNL 1260' FWL Unit D Sec 8 T24S R29E

The adjoining units towards which the unorthodox location encroaches are located in T24S R29E, Section 20 - Units C, D, E, F and Section 5 - Units A, B, C, D, E, F, G, H, I, J, K, L, M, N, O, P.

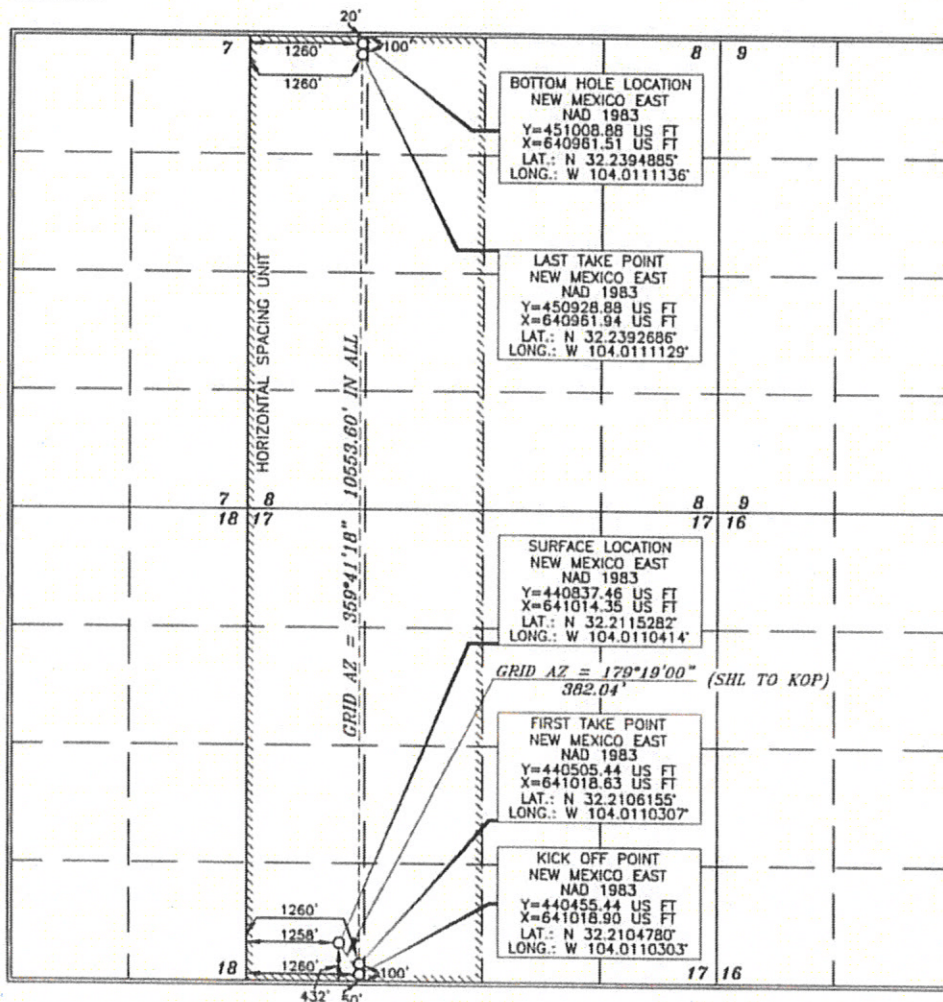

Dear Mr. Lowe:

Oxy USA Inc. respectfully seeks approval for a non-standard location, decreasing the first and last take point for Oxbow CC 17-8 Federal Com 32H in the Wolfcamp formation of the Purple Sage Pool from 330 feet to 100 feet. It is Oxy's responsibility as a prudent operator to maximize lateral length and minimize reserves left in the ground. Decreasing the first and last take point will increase this well's effective lateral length by 460 feet and increase the estimated ultimate recovery of the well by approximately 5%. Any increase in first or last take point would result in untapped reserves left in the reservoir, and waste of a resource that would otherwise go undeveloped.
