Mr. Gutierrez,

OCD was notified by the New Mexico State Land Office (SLO) that they are protesting this application. This party has been identified as an affected person for the location being considered. Because of the protest, the application can no longer be reviewed administratively. You are being notified that for this application to be considered, 3Bear Field Services, LLC., currently has two options; the first is to go to hearing, the second is to negotiate a resolution with the protesting party. If the protest is withdrawn, then the application can be reviewed administratively. In the meantime, the application will be retained pending a hearing or other resolution.

Additionally, a preliminary review of the application showed that both Centennial Resources Production, LLC. and Chase Oil Corporation, who were both identified as Lessees within the area of review (AOR), were not sent notice letters. The Application cannot be considered administratively complete until all parties within the AOR have received notice and had the opportunity to protest.

Please continue to provide OCD with information regarding the status of the negotiations with the protesting party and the issuance of notice to affected parties.
