Re: Application of Matador Production Company to authorize pool commingling, off-lease storage, off lease measurement, and off-lease marketing at the Biggers Fed West Tank Battery located in the SW/4 SE/4 (Unit O) of Section 18, Township 25 South, Range 35 East, NMPM, Lea County, New Mexico.

Dear Ms. Sandoval:

Pursuant to 19.15.12.7 NMAC, individual spacing units are considered separate “leases” for surface commingling purposes. Accordingly, Matador Production Company (OGRID No. 228937) seeks administrative approval for pool commingling, off-lease storage, off-lease measurement, and off-lease marketing at the Biggers Fed West Tank Battery of production from the Dogie Draw; Delaware (97779); and the Dogie Draw; Wolfcamp (17980) pools from *all existing and future wells drilled in the following “leases”*:

(a) The 160-acre, more or less, spacing unit in the Dogie Draw; Delaware (97779) underlying the E/2 E/2 of Section 18. The spacing unit is currently dedicated to the **Biggers Fed Com #024H well** (API No. 30-025-44480);

(b) The 160-acre, more or less, spacing unit in the Dogie Draw; Wolfcamp (17980) underlying the W/2 E/2 of Section 18. The spacing unit is currently dedicated to the **Biggers Fed Com #203H well** (API No. 30-025-44645), and the **Biggers Fed Com #217H well** (API No. 30-025-44646);

(c) The 160-acre, more or less, spacing unit in the Dogie Draw; Delaware (97779) underlying the E/2 E/2 of Section 18. The spacing unit is currently dedicated to the **Biggers Fed Com #214H well** (API No. 30-025-44483); and

(d) Pursuant to 19.15.12.10.C(4)(g), *future spacing units connected to this central tank battery* with notice provided only to the interest owners within these future “leases.”

Oil and gas production from these “leases” will be commingled and sold at the Biggers Fed West Tank Battery located in the SW/4 SE/4 (Unit O) of Section 18. Prior to commingling, gas production from each “lease” will be separately metered using individual test separators with calibrated orifice meters that are manufactured to AGA specifications. Oil production from each “lease” will also be separately metered using turbine meters.

Exhibit 1 is a land plat showing Matador’s current development plan, flow lines, and central tank battery (“production facility”) in the subject area. The plat identifies the wellbores, the existing spacing units, and the common surface facilities located in the SW/4 SE/4 (Unit O) of Section 18.

Exhibit 2 is a C-102 for each of the wells currently permitted or drilled within the existing spacing units.

Exhibit 3 is a completed Application for Surface Commingling (Diverse Ownership) Form C-107-B, that includes a statement from Benjamin D. Peterson, P.E., Senior Production Engineer with Matador, identifying the facilities and the measurement devices to be utilized, a detailed schematic of the surface facilities (attachment A to the statement) and a referenced gas sample (attachment B to the statement).

Exhibit 4 is a list of the interest owners (including any owners of royalty or overriding royalty interests) affected by this application, an example of the letters sent by certified mail advising the interest owners that any objections must be filed in writing with the Division within 20 days from the date the Division receives this application, proof of mailing, and affidavit of publication. A courtesy copy of this application has been provided to the Bureau of Land Management since federal lands are involved.

Re: Application of Matador Production Company for administrative approval to surface commingle (pool and lease commingle) production from the spacing units comprising the E/2 of Section 18, Township 25 South, Range 35 East, NMPM, Eddy County, New Mexico (the "Lands")

To Whom This May Concern,

Matador Production Company ("Matador"), OGRID: 228937, requests to commingle future oil and gas production from four (4) distinct wells located on the Lands and future production from the Lands as described herein. All wells will be metered through individual three-phase separators with an oil turbine meter and gas orifice meter. The gas commingling will occur after individual measurement at each well. Gas exiting each well test flows into one gathering line, as depicted on **Exhibit A**, the Longwood Gathering line. Each well on the Lands will have its own three-phase separator with an orifice meter manufactured and assembled in accordance with American Gas Association (AGA) specifications. All primary and secondary Electronic Flow Measurement (EFM) equipment is tested and calibrated by a reputable third party measurement company in accordance with industry specifications.

The orifice meter is the preferred measurement device utilized by midstream and E&P companies in natural gas measurement. The gas samples are obtained at the time of the meter testing/calibration and the composition and heating value are determined by a laboratory in accordance with American Petroleum Institute (API) specifications to ensure accurate volume and Energy (MMBTU) determinations. See example from Fesco Laboratory attached as **Exhibit B** hereto.

The flow stream from each wellhead is demonstrated in the Process Flow Diagram (PFD) attached as **Exhibit A** hereto. The PFD shows that the water, oil, and gas leave the wellbore and flow into a wellhead three-phase separator which separates the oil, gas, and water. The oil is measured via turbine meter which is calibrated periodically in accordance with industry specifications by a third party measurement company for accuracy. The gas is measured on a volume and MMBTU basis by an orifice meter and supporting EFM equipment in accordance with American Petroleum

Association (API) Chapter 21.1. The gas is then sent into a gathering line where it is commingled with each of the other wells' metered gas. The gathering line gas is then metered by another orifice meter at the tank battery check to show the total volume of gas leaving the Tank Battery. This meter is tested and calibrated in accordance with industry specifications and volume and energy are determined on an hourly, daily, and monthly basis. Once the gas exits this final tank battery sales check it travels directly into a third party sales connect meter. Longwood Gathering has its own orifice meter that measures the gas for custody transfer. These meters are also calibrated periodically to ensure the measurement accuracy.

In conclusion, all the oil and gas produced on the Lands is and will be metered at each wellhead and allocated correctly using the same measurement equipment as the pipeline sales measurement specifications accepted by API as industry standard.
