OXY USA Inc. respectfully requests to amend previously submitted application dated September 17, 2019 for administrative approval of a non-standard location on the Salt Flat CC 20-29 Federal Com 38H well, API Number 30-015-46399, Property Code 321601. This amendment will change the Last Take Point of the completed interval from 100' FSL to 330' FSL. The NSL application was initially protested on October 7, 2019. The Protestant was removed from the encroaching track by changing the Last Take Point to an orthodox location. The 38H well is proposed to be completed in the Purple Sage Wolfcamp pool, Pool Code 98220, which has special pool rules specifying the completed interval must be located 330 feet from the exterior boundary of the applicable spacing unit. The proposed completed interval is projected as follows:

Surface – 435' FSL 1835' FWL Unit N Sec 17 T24S R29E
First Take Point – 100' FNL 2310' FEL Unit B Sec 20 T24S R29E
Last Take Point – 330' FSL 2309' FEL Unit O Sec 29 T24S R29E
Bottom Hole – 20' FSL 2310' FEL Unit O Sec 29 T24S R29E

The adjoining units towards which the unorthodox location encroaches are located in T24S R29E, Section 17 - Units I, J, O and P.




