Franklin Mountain Energy, LLC ("FME"), OGRID Number 373910, is seeking administrative approval of an unorthodox well location ("NSL") for the **Blue Ribbon Fed Com 703H well** (the "Well") to be completed within the WC-025 G-09 S253502D Upper Wolfcamp Pool (98187) underlying the E/2 W/2 of Sections 2 and 11, Township 25 South, Range 35 East, N.M.P.M., Lea County, New Mexico. A C-102 for the Well is attached as Exhibit A. This is a horizontal well that will be drilled as follows:

- Surface Hole Location: 675' from the North line and 2623' from the West line of Section 2;
- First Take Point: 693' from the North line and 2609' from the West line of Section 2;
- Last Take Point and Bottom Hole Location: 150' from the South line and 2610' from the West line of Section 11.

FME has included as Exhibit B a letter explaining why this application is needed. This well will produce from the WC-025 G-09 S253502D Upper Wolfcamp Pool (98187). This pool follows statewide pool rules, which establish 100' setbacks for first and last take points and 330' setbacks for completed laterals. The completed lateral for the proposed well is closer than 330' from the boundary of the spacing unit.

The unorthodox location will encroach towards the (1) W/2 E/2 of Section 2, Township 25 South, Range 35 East, and (2) W/2 E/2 of Section 11, Township 25 South, Range 35 East.




Franklin Mountain Energy, LLC kindly requests the administrative approval of the non-standard location for the Blue Ribbon Federal 703H well, to be drilled in WC-025 G-09 S253502D; UPR WOLFCAMP pool (Oil) (WC-98187). Franklin Mountain Energy plans for this well to have a first take point at approximately 693' FNL and 2,609' FWL of Section 2 and a last take point at least 150' FSL and approximately 2,610' FWL of Section 11, which is closer to the unit line than allowed under the subject field rules. Franklin Mountain Energy requests this non-standard location because such placement relative to offset planned wellbores optimizes the geometric configuration and subsequent resource recovery under the current development plan.






