Dear Ladies and Gentlemen:

On behalf of Intrepid Potash-New Mexico, LLC, we are submitting this objection to and request for a hearing on the referenced Application for Authorization to Inject.

The land on which the SWD well proposed by the Application would be drilled is owned by the United States. Intrepid New Mexico holds BLM Grazing Permit NM 76033 for that land.

The proposed SWD well would be within approximately 100 feet of land in NW1/4 Section 5, Township 26 South, Range 34 East, owned in fee by Intrepid New Mexico.

Finally, the proposed SWD well would be within one mile of at least three water wells owned by Intrepid New Mexico – C-02292 POD1, C-03341 POD 1, and C-03442 POD 1. Intrepid New Mexico owns one additional water well – C-02291 – which it believes also to be within one mile of the proposed SWD well but which the Oil Conservation Division's records indicate is about 20 feet beyond the one-mile radius from the proposed SWD well.

Intrepid New Mexico hereby objects to and requests a hearing on the Application.
