Centennial Resource Production, LLC (“Centennial”) (OGRID No. 372165) seeks administrative approval of an unorthodox well location for its **Queso Blanco 13 State Com #603H Well** (API No. 30-025-46400) to be completed within the Ojo Chiso; Bone Spring Pool (Pool Code 96553) underlying the SW/4 of Section 12 and the W/2 of Section 13, Township 22 South, Range 34 East, N.M.P.M., Lea County, New Mexico.

This well has been drilled from a surface location 1225 feet from the south line and 1562 feet from the west line (Unit N) of Section 13, to a bottom hole location 2534 feet from the south line and 2326 feet from the west line (Unit K) of Section 12. The first take point will be located 377 feet from the south line and 2077 feet from the west line (Unit N) of Section 13, and the last take point will be 2534 feet from the south line and 2326 feet from the west line (Unit K) of Section 12.

Since this acreage is governed by the Division’s statewide rules, the completed interval for the **Queso Blanco 13 State Com #603H** is unorthodox because the completed interval is closer than the standard offsets to the eastern boundary of the spacing unit in the NE/4 SW/4 (Unit K) of Section 13. Approval of the unorthodox completed interval will allow Centennial to use its preferred well spacing plan for horizontal wells in this area and thereby prevent waste.

Exhibit A is a Well Location and Acreage Dedication Plat (Form C-102), which shows that the completed interval of the proposed **Queso Blanco 13 State Com #603H** encroaches on the drilling and spacing units to the east.

Exhibit B is a land plat for Sections 11, 12, 13, and 14, that shows the proposed **Queso Blanco 13 State Com #603H** in relation to the adjoining spacing units to the east in Sections 12 and 13.

Exhibit C is a list of the parties affected by the encroachment to the east. Ownership is diverse between the subject spacing unit and the tracts to the east. The affected parties in the spacing units in the W/2 E/2 of Section 13, include the New Mexico State Land Office. A copy of this application with all attachments has been sent by certified mail to each affected party advising them that if they have an objection it must be filed in writing with the Division within 20 days from the date the Division receives the application. Waivers from both of the affected parties are also included as reflected below:

Centennial Resource Production, LLC respectfully requests administrative approval on a non-standard location for the Queso Blanco 13 State Com #603H to allow the completed interval to be less than 330 feet from the eastern boundary of the existing 480-acre horizontal spacing unit. This well is located in the Ojo Chiso; Bone Spring Pool (96553) and was intended to be drilled as a standard location. Due to difficulties during drilling operations the well is non-standard.
