COG Operating, LLC, respectfully requests approval to amend Administrative Order CTB-832 for Off-lease Measurement and Pool/Lease Commingling of gas to include the following wells:

- Huckleberry State Com 501H, API# 30-025-45231, Ut. A, Sec. 27-T21S-R33E, Lea County, NM
- Huckleberry State Com 502H, API# 30-025-45232, Ut. B, Sec. 27-T21S-R33E, Lea County, NM
- Huckleberry State Com 503H, API# 30-025-45233, Ut. B, Sec. 27-T21S-R33E, Lea County, NM
- Huckleberry State Com 504H, API# 30-025-45234, Ut. C, Sec. 27-T21S-R33E, Lea County, NM
- Huckleberry State Com 505H, API# 30-025-45207, Ut. D, Sec. 27-T21S-R33E, Lea County, NM
- Huckleberry State Com 506H, API# 30-025-45208, Ut. D, Sec. 27-T21S-R33E, Lea County, NM

Currently Administrative Order CTB-832 includes the Pygmy 27 State Com #1H-3H wells which are communitized into one 480 acre spacing unit. The Raspberry State Com #1H well has a separate communitization agreement. All gas produced from the four wells are surface commingled and sold at the ETC gas sales meter #68870 located at the Pygmy 27 State Com #1H battery in Ut. D, Sec. 27-T21S-R33E.

On occasion, the ETC gas sales line used by the Pygmy/Raspberry wells will be shut in for extended periods of time. In order to prevent the unnecessary flaring of gas, we are requesting OCD approval to utilize the Targa gas meter #161001222 by commingling the Raspberry/Pygmy gas with Huckleberry gas when the ETC gas line is shut in.

Please find the attached Administrative Application Checklist, plats for referenced wells, proof of notice to interest owners, diagrams of site facilities, map with lease boundaries showing wells and facility locations and a copy of the letter to the New Mexico State Land Office.


