Thanks for sending the additional material. However, I am still unable to consider the application administratively complete. In order to do so, the Oil and Gas leaseholder information will need to be more clearly defined. I am unable to reconcile the provided lease holder excel spreadsheet with the associated maps. I am also unable to easily add the spreadsheet into the online administrative record. I will be needing a map that clearly shows the referenced leases and then a list that tabulates the associated leaseholder and affected parties information onto one page that can be uploaded as a PDF document.

Additionally, because it seems like many of the wells within the AOR penetrate, or are deeper than the intended injection interval, we will need:

- Tabulation of data for all wells of public record within AOR which penetrate the proposed injection zone, including well type, construction, date drilled, location, depth, and record of completion.
- A Schematic of each plugged well within AOR showing all plugging detail

You can submit these additional materials along with the proof of notice for the BLM and SLO as soon as they are compiled.
