Mr. Glover,

Upon further review, the Long Shot SWD No. 1 application needs additional AOR notice. Within the initial application, affected parties within one half mile of the well were notified. However, current OCD policy is such that large commercial Siluro-Devonian wells require a one mile AOR notice. An additional suggestion for these wells is a statement by a qualified person assessing the potential of induced-seismic events associated with the disposal activities for the predicted service life of the proposed well.

Therefore, please provide the Division of a list of affected parties within one mile of the proposed well location and send notice to any additional affected parties who did not receive notice in the initial one half mile mailing and provide any information on wells that penetrate the proposed injection interval within one mile. Additionally, but not mandatory, provide a statement with regards to the potential for induced seismicity with this well.

Other than this last requirement, I will have the order prepared and ready to go for whenever the notice requirement is attended to.


