Re: Application of Marathon Oil Permian LLC for administrative approval of unorthodox well location Honey Mustard 22 WXY Fed Com 6H well located in the W/2 of Section 22, Township 24 South, Range 28 East, NMMPM, Eddy County, New Mexico.

Dear Director Sandoval:

Marathon Oil Permian LLC (“Marathon”), OGRID Number 372098, is seeking administrative approval of an unorthodox well location (“NSL”) for the **Honey Mustard 22 WXY Fed Com 6H well** (the “Well”) to be completed within the Purple Sage Wolfcamp Gas Pool (Pool ID: 98220) underlying the W/2 of Section 22, Township 24 South, Range 28 East, NMMPM, Eddy County, New Mexico. A C-102 for the Well is attached as Exhibit A, along with additional maps showing the vicinity and the affected tracts. This is a horizontal well that will be drilled as follows:

- Surface Hole Location: 479’ from the South line and 1019’ from the West line of Section 22;
- First Take Point: 100’ from the South line and 2178’ from the West line of Section 22;
- Last Take Point and Bottom Hole Location: 100’ from the North line and 2178’ from the West line of Section 22.

Marathon has included as Exhibit B a letter explaining why this application is needed. Marathon also provides a midland map of this area, attached as Exhibit C.

This well will produce from the Purple Sage Wolfcamp Gas Pool (Pool ID: 98220). The special pool rules establish 330’ foot setback requirements. The completed interval for the proposed well is closer than 330’ from the boundary

of the spacing unit. The unorthodox location will encroach towards the SW/4 of Section 15 and the NW/4 of Section 27 of Township 24 South, Range 28 East.

Marathon is providing notice to the working interest owners in the SW/4 of Section 15, Township 24 South, Range 28 East and the NW/4 of Section 27 of Township 24 South, Range 28 East. Marathon has confirmed that the tracts adjoining the spacing unit by a corner are more the 330' away from the unorthodox locations requested. Marathon is also providing notice to the Bureau of Land Management and State Land Office as owners of the minerals in the NW/4 of Section 27. Proof of mailing, along with a copy of the notice letter sent to affected parties, is attached hereto as Exhibit D.







Marathon Oil Permian LLC respectfully requests administrative approval of the non-standard location for the Honey Mustard 22 WXY Fed Com 6H well, to be drilled in Purple Sage; Wolfcamp (Gas) pool (98220). Marathon plans for this well to have a first take point at 100' FSL and 2,178' FWL of Section 22, and last take point at 100' FNL and 2,178' FWL of Section 22, which is closer to the unit line than allowed under the subject field rules. Marathon requests this non-standard location because the placement conforms to the first and last take points of the other wells in the section. This spacing best fits into the spacing for the other wells in the development plan of the entire section and we believe that it will result in the greatest recovery of reserves.


