**Re: Application of Ameredev Operating, LLC to authorize lease commingling, off-lease storage, off-lease measurement, and off-lease marketing, at the Firethorn Fed Com Central Tank Battery located in the NE/4 NW/4 (Unit C) of Section 4, Township 26 South, Range 36 East, NMPM, Lea County, New Mexico.**

Dear Ms. Sandoval:

Pursuant to 19.15.12.7 NMAC, individual spacing units are considered separate “leases” for surface commingling purposes. Accordingly, Ameredev Operating, LLC (OGRID No. 372224) seeks administrative approval for lease commingling, off-lease storage, off lease measurement, and off-lease marketing, at the **Firethorn Fed Com Central Tank Battery** of production from the WC-025 G-09 S263619C: Wolfcamp (98234) pool from *all existing and future wells drilled in the following “leases”*:

(a) The 320-acre, more or less, spacing unit in the WC-025 G-09 S263619C: Wolfcamp (98234) pool underlying the E/2 W/2 of Sections 4 and 9. The spacing unit is currently dedicated to the **Firethorn Federal Com 26 36 04 #113H well** (API No. 30-025-44961);

(b) The 640-acre, more or less, spacing unit in the WC-025 G-09 S263619C: Wolfcamp (98234) pool underlying the E/2 E/2 of Sections 4 and 9 and the W/2 W/2 of Sections 3 and 10. The spacing unit is currently dedicated to the **Pimento Federal Com 26 36 03 #111H well** (API No. 30-025-45633); and

(c) Pursuant to 19.15.12.10.C(4)(g), *future spacing units connected to this central tank battery* with notice provided only to the interest owners within these future “leases.”

Oil and gas production from these “leases” will be commingled and sold at the Firethorn Fed Com Central Tank Battery located in the NE/4 NW/4 (Unit C) of Section 4. Prior to commingling, gas production from each “lease” will be separately metered using individual test separators with

calibrated orifice meters that are manufactured to AGA specifications. Oil production from each "lease" will also be separately metered using turbine meters.

**Exhibit 1** is a land plat showing Ameredev's current development plan for these wells, the corresponding lease names and numbers, the pad sites, and the common surface facilities located in the NE/4 NW/4 (Unit C) of Section 4.

**Exhibit 2** is a C-102 for each of the wells currently permitted or drilled within the existing spacing units, together with available production reports for the Firethorn Fed Com wells. There are not yet any production reports for the Pimento Fed Com 26 36 03 #111H well.

**Exhibit 3** is a completed Application for Surface Commingling (Diverse Ownership) Form C-107-B, that includes a statement from Shane McNeely, P.E., Engineer with Ameredev, identifying the facilities and the measurement devices to be utilized, a detailed schematic of the surface facilities (attachment A to the statement).

**Exhibit 4** is a list of the interest owners (including any owners of royalty or overriding royalty interests) affected by this application, an example of the letters sent by certified mail advising the interest owners that any objections must be filed in writing with the Division within 20 days from the date the Division receives this application, and proof of mailing. A copy of this application has been provided to the Bureau of Land Management since federal lands are involved.

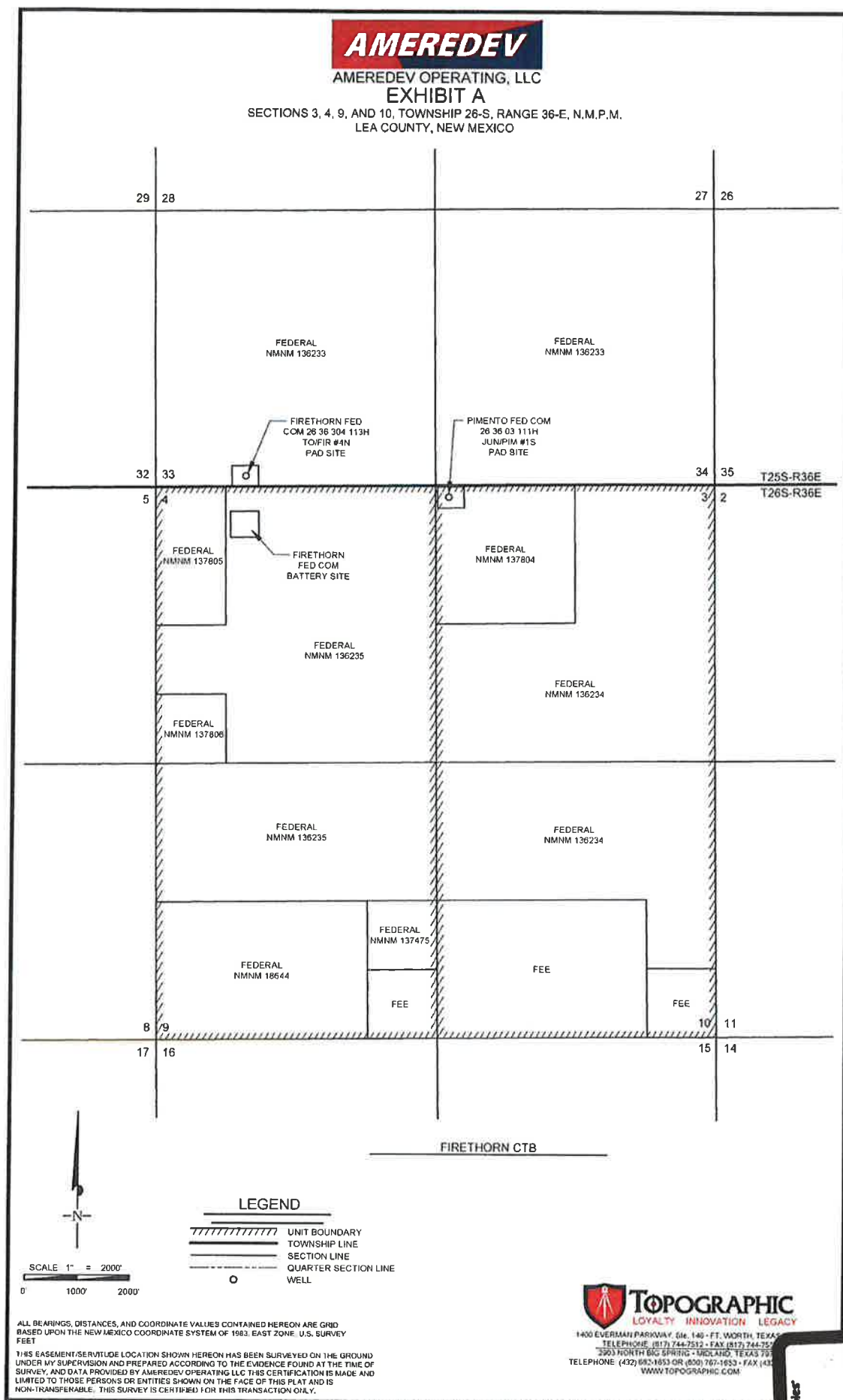

Ameredeve Operating, LLC, OGRID: 372224, requests to commingle current oil and gas production from the Firethorn Fed Com 26 36 04 and the Pimento 26 36 03 Federal Com Leases. All wells will go through individual three phase separators and each stream (oil, water, gas) will be measured as it exits the three phase separator. Oil will be measured at the three phase separator with a Coriolis meter; gas will be measured with an orifice meter, and water will be measured with a mag meter.

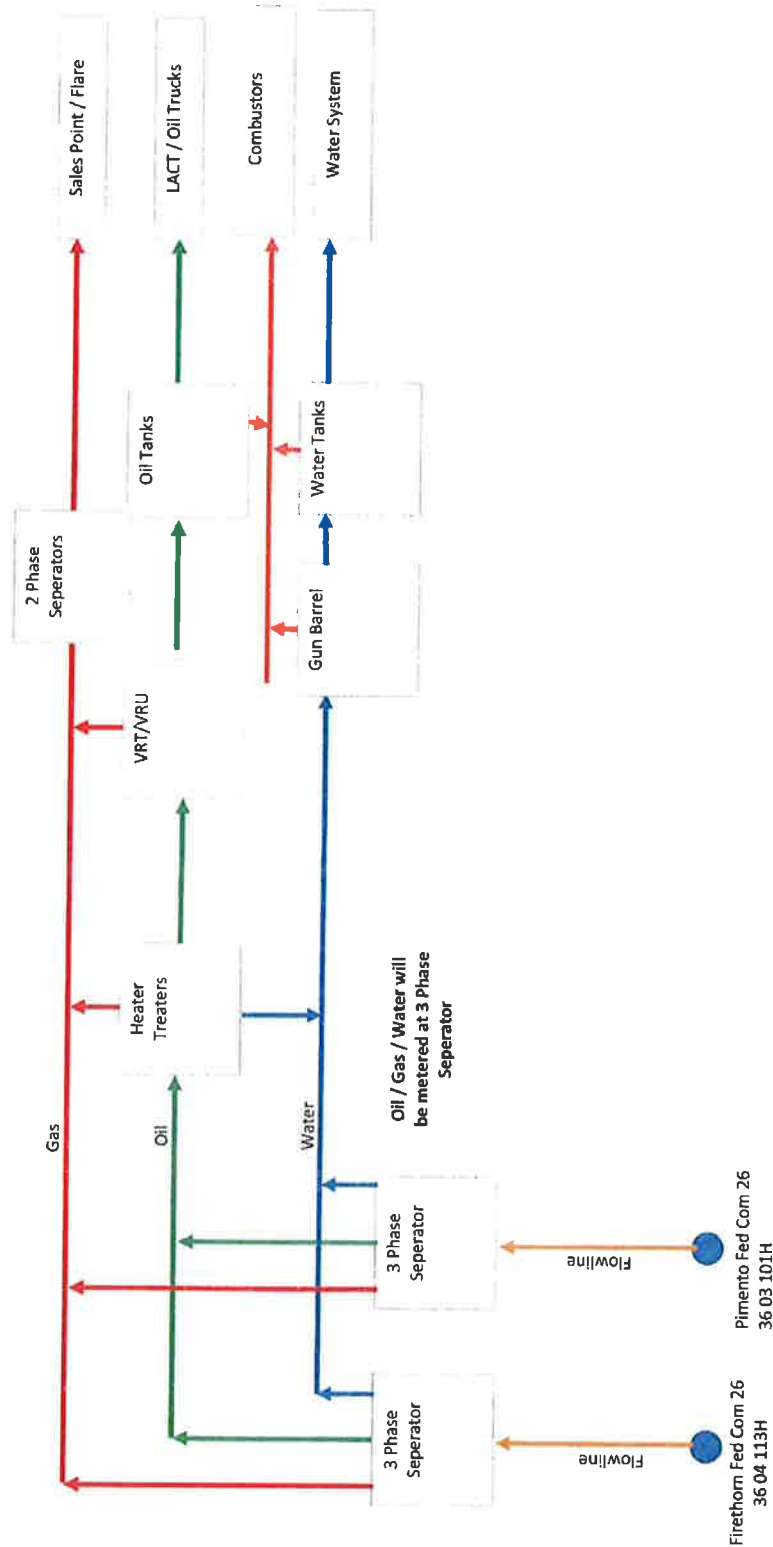
Commingling will happen after the three phase separator. The gas stream will flow into a common line and flow into an additional two phase separator to remove any excess water. Gas from the heater treater and the vapor recovery tower will also be going into the two phase separator before it is sent to our gas gathering pipeline system. The oil will flow into a common line after the three phase separator and will flow into a heater treater and a vapor recovery tower to remove any remaining water and gas in the oil stream. The oil will then go to lined oil tanks to be either trucked off or piped into our crude gathering pipelines. The water will be commingled after the three phase separator into a common line that will flow into a gun barrel before it is pumped into our water pipeline system. The gas will be allocated against a main sales meter and the oil will be allocated against the CTB LACT meter. All meters will be calibrated according to manufacturer's recommendations.

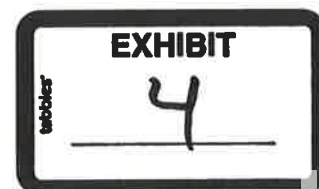
