CHEVRON REQUESTS THE APPROVAL TO MINIMIZE SURFACE DISTURBANCE AND FUTURE TRAFFIC BY CONCENTRATING ACTIVITIES AT ONE BATTERY. THE WELLS PRODUCING TO THIS BATTERY, INCLUDE THE KEEL A FEDERAL #3, KEEL A FEDERAL #4 AND KEEL A FEDERAL #2. THESE WELLS ARE LOCATED IN SECTION 33, T-18S, R-32E IN LEA COUNTY, NEW MEXICO.

THE WELLS ARE LOCATED ON FEDERAL LEASES NMNM0556094 AND NMNM24161 AND THE ROYALTY RATE IS IDENTICAL FOR ALL ZONES INVOLVED IN THIS REQUEST. THESE WELLS WERE COMPLETED IN 1996 & 1998. THE KEEL A FEDERAL #3, KEEL A FEDERAL #4 AND KEEL A FEDERAL #2 WILL BE TESTED CONTINUOUSLY THROUGH TURBINE METERS INSTALLED ON HEATER TREATERS AND THE GAS ALLOCATION METER. THERE ARE TWO OIL TANKS AT THE CTB THAT THE WELLS UTILIZE AND TOTAL OIL WILL BE MEASURED BY HAVING A QUALIFIED FIELD PERSONNEL
