Dear Mr. McClure:

FAE II Operating LLC, OGRID: 329326, requests administrative approval for surface commingling of gas production from the Jalmat Oil and Gas Pool for its R W Cowden C #12 well located in Section 31, T-23S, R-37E as shown on the map in Exhibit A. The existing R W Cowden Compression System is comprised of the R W Cowden #1; the R W Cowden B #4; the R W Cowden C #4, and #10; and the State LMT #5, #8, #9, #10, and #11 wells. The leases are also identified by outline and legend. Exhibit B offers further detail on the relevant wells on the leases.

The attached battery diagrams, Exhibits C and D, are accurate schematics of the current facility and the proposed commingled facility, respectively. A new gas flowline will be laid from the R W Cowden C #12 and tied in to the suction side of the compressor at the Cowden CRP, which is the sales point of the R W Cowden Compression System.

Pursuant to paragraph (3) of Subsection C of 19.15.12.10 NMAC, FAE II Operating LLC requests to estimate gas production on each of the R W Cowden #1, R W Cowden C #4, R W Cowden C #12, State LMT #5, State LMT #8, and State LMT #10 wells as an alternative to individual well measurement, seeing as none have averaged over 15 Mcf/d in the past year as shown in Exhibit F. Should this aspect of our proposal be approved, we would not need to install any orifice (allocation) meter for the purposes of measuring gas production. The gas production from the remaining wells in the compression system would be measured by the metering method. Total production for the wells will be measured by the lease custody transfer meter at the Cowden CRP.

After a review of internal records, the interest owners are not identical for the wells mentioned above. As such, we have notified all relevant parties of our intent to commingle production (see attached letter). The working and royalty interest owners as shown in Exhibit E have been notified of this application by certified mail. Copies of the certified mail receipts are attached as Exhibit G.

This proposed commingling of production is in the interest of conservation and will not result in reduced royalty or improper measurement of production. Exhibit A – Lease Boundaries Map

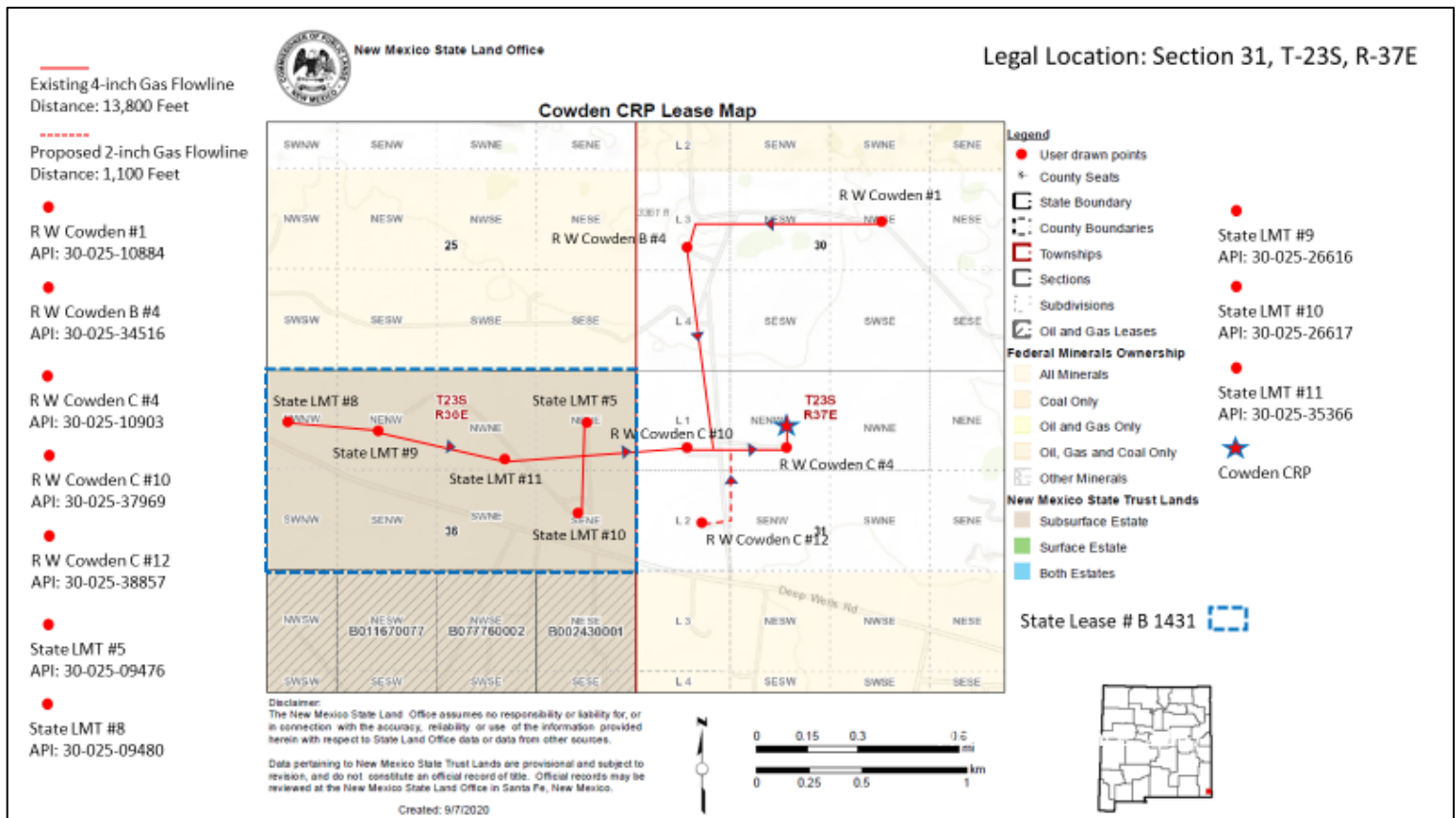
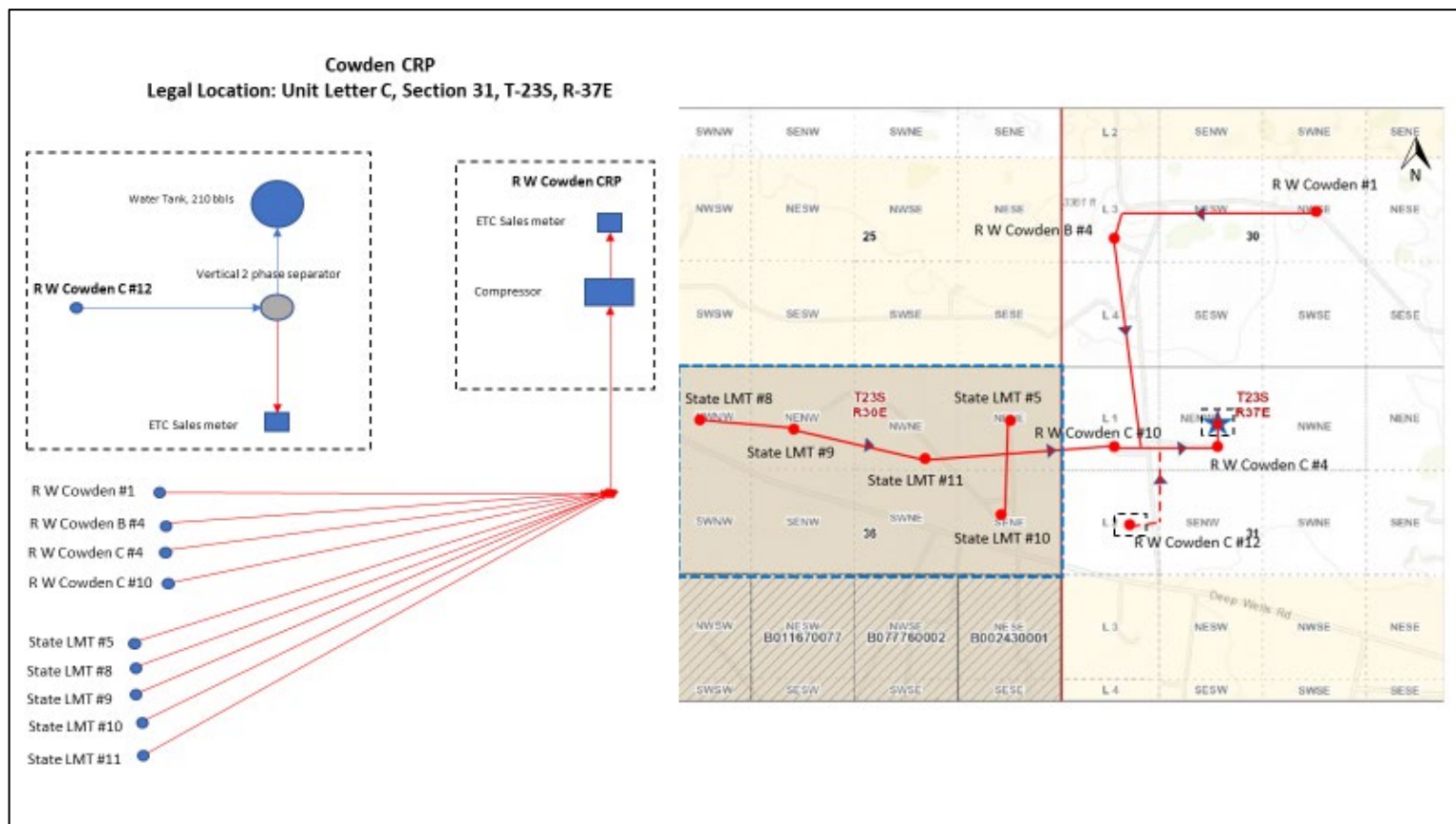

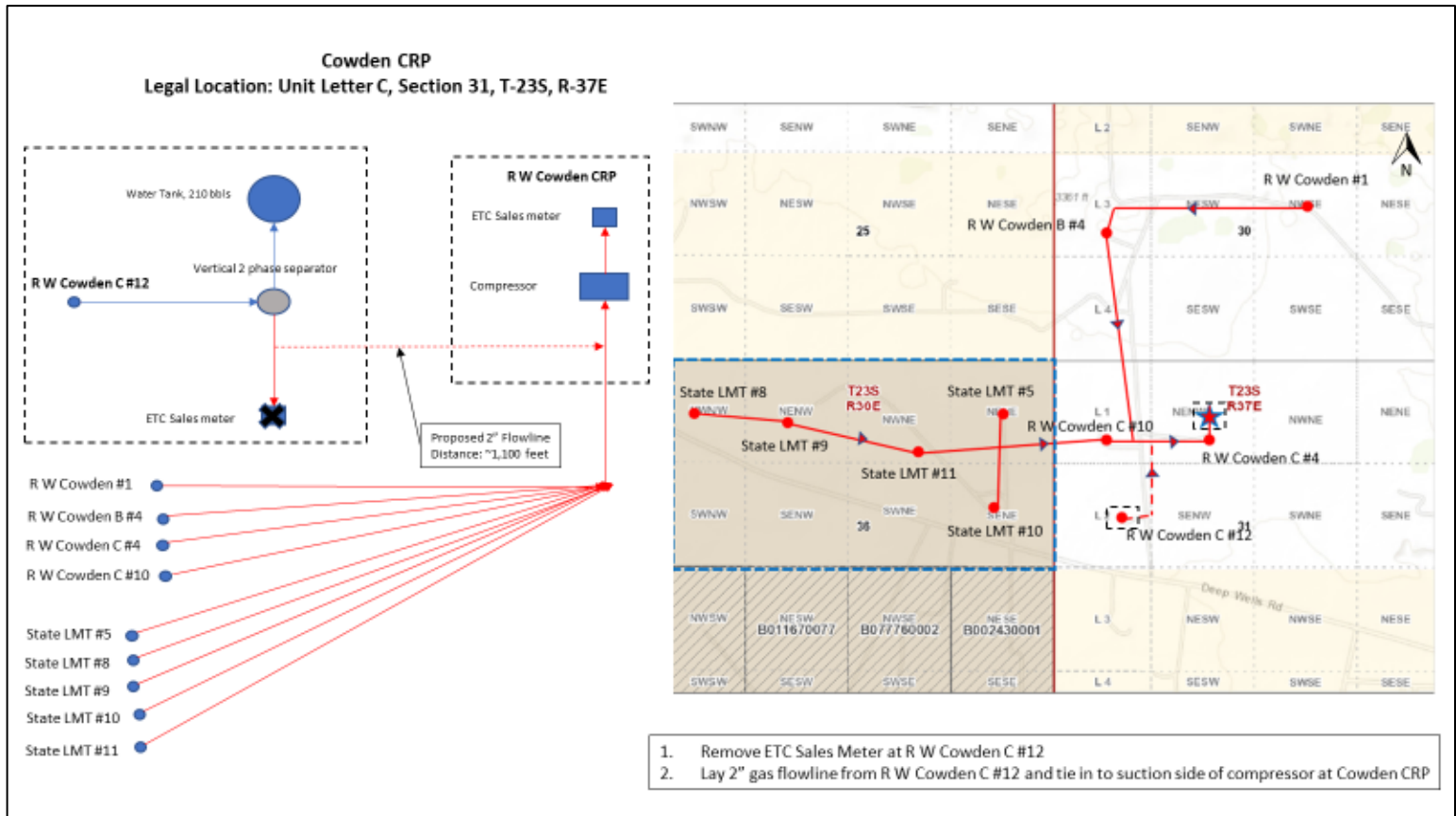
